WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

This is an update on recent changes to the ABC recruitment and appointment process as directed by the Board of County Commissioners (BCC) on 10/29/2013. Following direction from the BCC, Public and Government Affairs (PGA) has implemented the following changes to the ABC program:

- Begin recruitment process 90days in advance
- Update bylaws to include terms, quorum rules and public meeting requirements
- Ensure all applicants apply for open positions, including those being reappointed

EXECUTIVE SUMMARY:

Public and Government Affairs coordinates the recruitment and appointment process in coordination with the department liaisons for the Clackamas County Advisory Board and Commission (ABC) program.

Since BCC direction in October 2013, PGA has implemented the following changes to the ABC Program:

- Notification must be made to PGA 90 days in advance of an ABC recruitment opening. Once notified, PGA will begin the recruitment process.
 - PGA is coordinating with liaison's to begin the recruitment process 90days in advance of term expirations. This provides adequate notification to the BCC to determine whether they would like to be involved in the interview process prior to formal appointment.
 - PGA is asking departments to continue the recruitment process until each position identified in the bylaws is filled.
 - Each candidate must fill out a new application even if they are seeking reappointment. The application provides up-to-date information, including participation on other ABC's.
 - PGA is providing an excel spreadsheet to the Policy Coordinators each week identifying active recruitments, which appointments are scheduled for the BCC, how many vacancies and upcoming recruitments.
 - There are circumstances where the 90-day recruitment does not apply, such as when a position is vacated prior to the end date.
- Although there are no limits to how many terms a volunteer can serve (unless specified in the bylaws or directed by the BCC), each ABC liaison has been asked to update or draft a set of bylaws that specify term lengths, quorum rules and public meeting requirements.
 - PGA has asked department liaisons to work with County Counsel to draft (if they do not have bylaws) or update their bylaws to include term

- expirations, quorum rules, and public meeting requirements. Currently, the ABC's work with County Counsel for guidance on bylaws prior to approval.
- ABC's (such as the Enhanced Law Enforcement Advisory Committee) are in the process of seeking committee approval to their updated bylaws.
- Currently, there is no internal process for bylaw approval. Bylaws are approved and managed by the associated department and the ABC.
- All applicants must complete an application including reappointments, during the open recruitment period.
 - To ensure a consistent process all applicants, including those being reappointed, must fill out a new application. It is at the discretion of the staff liaison, committee and the BCC to decide if a person can be reappointed, unless term limits are identified in the bylaws.
 - PGA has created a database that keeps a record of who has applied, who has been appointed and who is serving on each ABC.

In addition to the changes mentioned above, PGA has implemented additional procedures to enhance internal communication, ensure recruitment and appointment consistency and to create better two-way communication with citizens. In addition to the changes above, PGA is:

- Training department liaisons to educate them on the ABC appointment process and required paperwork (these will be annual trainings).
- Working with TS to create better access to the ABC webpage and ease for the online application process.
- Looking at options for ABC's that are no longer active or no longer serve the purpose for which they were created.
- Creating a new system to organize databases, documents and information about each ABC.
- Coordinating with department liaisons to correspond with incoming and outgoing volunteers thanking them for their interest or service and letting them know their application status.
- Coordinating with departments to remind them of pending ABC term expirations.
- Enhancing the recruitment process to include new and innovative ways of recruiting members.
- Communicating regularly with Policy Coordinators showing the status of open recruitments and upcoming recruitments.

LEGAL/POLICY REQUIREMENTS:

Each ABC follows requirements set forth in state statute, BCC ordinance or ABC bylaws.
