Approval of Intergovernmental Agreements with Cities for Energy Retrofits of City Buildings

ISSUE & BACKGROUND

The County has received funds through the Energy Efficiency and Conservation Block Grant ("EECBG") established as part of the American Recovery and Reinvestment Act of 2009. These funds cover multiple activities, from public building energy efficiency retrofits to loans for residential energy upgrades, throughout the entire county except within the City of Lake Oswego, which received its own grant. The public building retrofit activity includes funding energy efficiency retrofits for city buildings in addition to county-owned buildings.

Four cities have buildings and grounds that have been evaluated for energy efficiency retrofits and they have requested EECBG funds to assist them. Funds are available beyond those that have been designated for county-owned buildings. These projects will be funded on a reimbursement basis and cities must apply for and deduct any Energy Trust of Oregon incentives applicable to each project prior to billing the County.

Time is critical as federal rules require that these intergovernmental agreements be executed by October 31, 2011 and all funds be spent prior to August 2012. Staff recommends that these Intergovernmental Agreements may be approved by the Department Director.

City of Wilsonville

\$16,168

City of Milwaukie

\$50,000, with option of additional \$50,000 if funds remain

City of Damascus

\$7,500

City of Sandy

\$20,000

County Counsel has reviewed and approved the Intergovernmental Agreements.

RECOMMENDATION

Staff respectfully recommends to the Board of County Commissioners approval of the above referenced Intergovernmental Agreements and that these agreements may be approved by the Department Director.

Approval of Intergovernmental Agreement#136598 with The State of Oregon, Department of Human Services, Senior and People with Disabilities Division for the Provision of Services to Clackamas County Residents age 60 and over

The Social Services Division of the Health, Housing & Human Services Department requests approval of Intergovernmental Agreement #136598, with the State of Oregon, acting by and through its Department of Human Services, Senior and People with Disabilities (DHS-SPD) Division for the provision of services to Clackamas County residents age 60 and over. This is a revenue agreement that provides funding for activities to enable residents of Clackamas County over age 60 to obtain services from Social Services Aging and Disability Services and its sub-contractors.

This agreement reflects the Older American Act (OAA) and Oregon Project Independence (OPI) funding for October 1, 2011 through June 30, 2013 of the 2011-2013 biennial agreement period. This funding will provide services for residents of Clackamas County who are age 60 and over by Social Services Division staff and/or sub-contractors. OPI funded services include case management and in-home services.

Total amount of this agreement is \$3,104,846. The agreement was reviewed and approved by County Council on September 14, 2011. No County General Funds are involved. This agreement is effective when signed by all parties or on October 1, 2011, whichever date is later; and terminates on June 30, 2013.

Recommendation:

We recommend the approval of this amendment and that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

Approval of the Renewal of an Intergovernmental Agreement with Oregon Housing and Community Services to Provide Rental Guarantees to Low-Income Clackamas County Residents through the Tenant Readiness Rent Guarantee Program

The Social Services Division of the Health, Housing and Human Services Department requests the approval of a Renewal of an Intergovernmental Agreement with Oregon Housing and Community Services to provide limited guarantees to low-income Clackamas County residents who are graduates of the Clackamas County Social Services (CCSS) Rent Well Program. Tenant Readiness Rent Guarantee Program allows up to \$20,000 to be expended on a reimbursement basis for unpaid rents and damages limited to \$2,000 per household that occur to landlords who have agreed to participate in the Rent Well program. The funds as presented by this agreement are important to the success of the program as they allow CCSS to offer this additional resource to landlords. It is noteworthy that during the life of the guarantee there has only been one claim. Rent Well clients who have been housed with the guarantee in place have been successful tenants.

This agreement was issued to Clackamas County Social Services Division on August 8, 2011. The commitment amount of the agreement is \$20,000. No County General Funds are involved. This agreement was reviewed and approved by County Counsel on September 25, 2011. This agreement covers the period of July 1, 2011 through June 30, 2012 and becomes effective upon acceptance by all parties.

Recommendation:

We recommend the approval of this intergovernmental agreement and that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

Approval of the 2011-2012 Oregon Health Plan Provider Services Contract for Mental Health Organizations with the Oregon Health Authority, Addictions and Mental Health Division

The Clackamas County Behavioral Health Division (CCBHD) of the Health, Housing and Human Services Department requests the approval of the 2011-2012 Oregon Health Plan Provider Services Contract for Mental Health Organizations with the Oregon Health Authority, acting by and through its Addictions and Mental Health Division to continue provision of mental health services to enrollees of the Oregon Health Plan (OHP) and State Children's Health Insurance Program (SCHIP).

This is a revenue contract. The compensation mechanism is structured on a per member, per month (capitation) basis for each OHP/SCHIP eligible individual enrolled in Clackamas, Hood River, Sherman, and Wasco Counties. Calculation of payments and rates are set forth in Exhibit C. This contract has been reviewed and approved by County Counsel on September 9, 2011. No County General funds are involved. It commences on October 1, 2011 and continues through September 30, 2012. It is retro-active due to late receipt from the State.

Approval of a Construction Agreement between the Community Development Division and RJR Construction for the Evergreen Annex Manufactured Home Improvements Project

The Community Development Division of the Health, Housing and Human Services Department requests the approval of a Construction Agreement with RJR Construction for the Evergreen Annex Manufactured Home Improvements Project. The designed home has six bedrooms, shared living common spaces, and will provide additional services for low and moderate-income women and children of Clackamas County. This improvement increases the number of beds available to victims of domestic violence.

Community Development published a solicitation for Request For Proposals. There were three contractors that submitted RFP's on September 12, 2011. Community Development assembled a review panel for the submittals. After the review process, RJR Construction scored the highest and was selected for this project. Below are the companies and their final scores for the RFP:

1. RJR Construction	85
2. Nomarco Construction	81
3. Nathan Daniel Young Construction	65

No County General Fund dollars are involved. The Construction Agreement was reviewed and approved by County Counsel on July 26, 2011.

APPROVAL OF A RESOLUTION ADOPTING CHANGED FEES FOR THE CLACKAMAS COUNTY CLERK FOR SOLEMNIZING A MARRIAGE

Please find attached a resolution adopting proposed fee changes for the Clackamas County Clerk for solemnizing a marriage.

During the 2011 legislative session, HB 2710 was adopted. This bill increases the fee for solemnizing a marriage from \$25 to \$100. Because this fee increase is a statutory change, the act of adopting it into the Clackamas County Code is purely clerical. The Clerk must charge \$100 for solemnizing a marriage because the legislative changes to the Oregon Revised Statutes require it. HB 2710 was effective on October 1, 2011.

If approved, the fees will be incorporated into County Code Appendix A, Fees, and will be effective immediately upon passage of the resolution.

RECOMMENDATION

The staff respectfully recommends that the Board approve and sign the attached resolution adopting changed fees for Clackamas County Clerk for solemnizing a marriage.

Approval to accept the 2011-2013 State Child Abuse Multidisciplinary Intervention (CAMI) Grant Program Award CAMI-MDT-2011-ClackamsCo.DAVAP-00039

Please find attached the CAMI-MDT grant award between the State of Oregon through the Department of Justice, Clackamas County, and the Clackamas County District Attorney's Office. This grant award will be used to provide a coordinated community response to the intervention, assessment, and investigation of child abuse.

The grant award is for \$614,506.26 and is budget neutral, as the District Attorney will pass through all funds to the Clackamas County Multidisciplinary Team (MDT). The stated goal of MDT is to provide high quality and comprehensive medical assessments and support services for Clackamas County children suspected to be victims of abuse as part of a coordinated response from Clackamas County's MDT partners.

The grant period is 24 months with a start date of July 1, 2011 through June 30, 2013.
