WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Approval of reallocation of ARPA dollars that are unspent and not obligated in formal contracts or agreements.

EXECUTIVE SUMMARY:

In June 2022, Clackamas County received its full grant award of \$81,227,922 of ARPA funding from the US Treasury. On May 17, 2023 the Board of County Commissioners completed allocating all of the funding for various projects.

Since that time staff have been working to develop agreements with organizations so that the ARPA dollars can assist our community. However, because of various reasons some of the allocated dollars cannot be used for the original intended purpose or because of timing cannot be obligated according to the US Treasury by December 31, 2024. Because of these circumstances staff are asking for the Board of County Commissioners to re-allocate those dollars to projects that can be obligated very quickly via formal contracts or agreements that satisfy the US Treasury requirements by December 2024. Any dollars that are not obligated by December 2024 will go back to the US Treasury.

Timing is critical as we move forward and ensuring we do not lose any ARPA dollars. Recommended projects are projects that can be put into agreements or contracts quickly and be executed by the end of the calendar year.
