EXECUTIVE SUMMARY: The original contract fully executed in September of 2023, for a term through June 30th, 2026.

The original contract value was \$102,554.00, and the scope or rates have since been amended three (3) times, representing past facility additions and subtractions including communication upgrades as necessary, increasing the Total Contract Value to \$134,494.68.

This amendment of \$19,908.18 provides the funding to continue monitoring current properties, necessary communication upgrades, the addition of the Recovery Center and the removal of the previous Gladstone Library location. The addition of Amendment No. 4 increases the Total Contract Value through June 30, 2026, to \$154,402.86.

RECOMMENDATION: Staff respectfully recommend that the Board approve and sign this contract amendment with Secure Pacific for Medical, Intrusion and Fire System Monitoring at Clackamas County properties.

AMENDMENT #4 TO THE CONTRACT DOCUMENTS WITH SECURE PACIFIC CORPORATION FOR ALARM MONITORING SERVICES Contract #8343

This Amendment #4 is entered into between **Secure Pacific Corporation** ("Contractor") and Clackamas County ("County") and shall become part of the Contract documents entered into between both parties on **September 11, 2023** ("Contract").

The Purpose of this Amendment #4 is to make the following changes to the Contract:

- 1. ARTICLE I, Section 2. **Scope of Work** is hereby amended as follows:

 By execution of this Amendment #4, County hereby authorizes, and Contractor agrees to perform, the following phone line upgrade work:

 - Brooks Building Upgrade to cellular

 - Development Services Building Add elevator and mechanical room monitoring

 - Multnomah Lodge Upgrade to cellular
 - Public Safety Training Center Upgrade to cellular
 - Clackamas MHC Upgrade to cellular
 - WES Tri-Cities Admin Building Upgrade to cellular
 - WES Tri-Cities Lab Building Upgrade to cellular
 - Recovery Center Adding monitoring to newly acquired building

By execution of this Amendment #4, the following locations and services will be added:

By execution of this Amendment #4, the following service location will be cancelled:

- Gladstone Library. 135 E Dartmouth St. Gladstone, OR 97027. Canceled on December 31, 2024
- 2. ARTICLE I, Section 3. **Consideration** is hereby amended as follows:

 In consideration for Contractor performing services at the new location

In consideration for Contractor performing services at the new locations, additional upgraded Work and for the cancelation of the one location described above, County shall pay Contractor an amount not to exceed \$19,908.18. Cost Breakdown for additional locations, upgraded Work and cancellations is further described in Exhibit A to this Amendment #4, attached hereto and incorporated by reference herein.
