**EXECUTIVE SUMMARY**: The purpose of this amendment request is to include a 5th support and service contract for the County's Finance and HR modules. Currently we have 4 support and service contracts, 2109189, 18889613, 18891081, and P-98-813-00-000--24. Based on our original agreement, US-PSFT-SLSA-12904429-30-SEP-1998, when the County's annual budget reaches certain thresholds, we're required to amend the contract to pay for additional support and services for the Finance module. This additional contract includes a one-time net license fee of \$205,870.10, plus a recurring annual support fee of \$43,057.87. This contract amendment will ensure that we will continue to receive software updates, support services from the vendor, and ensure that our staff have the resources they need to keep Peoplesoft systems operational. This increase was expected and included in our adopted budget. Approval of the board order will delegate authority for County Finance to amend purchase order 35206 to include the additional support and service contract for continuation of our Peoplesoft support services.

**RECOMMENDATION:** Staff respectfully recommends the Board of County Commissioners authorize Procurement to amend PO 35206 to add a technical support and services contract with Oracle America Inc.
