WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

No action is requested. The intent of this session is to update the Board about planning topics related to the McLoughlin Boulevard area in unincorporated Clackamas County:

- ISOCARP Young Planning Professionals Project
- Voluntary mechanism to prevent up-zoning and/or dividing land in low-density residential neighborhoods
- Park Avenue Development and Design Standards project grant application

EXECUTIVE SUMMARY:

 ISOCARP Young Planning Professionals Project – The McLoughlin Corridor was the focus of a project for young planning professionals in late October, as part of the joint conference of the International Society of City and Regional Planners (ISOCARP) and the Oregon Chapter of the American Planning Association that was held in Portland in late October.

As discussed with the Board at a policy session in September, as part of the annual ISOCARP conference, the host jurisdiction sponsors and provides a project for ISOCARP's Young Professional Planners (YPPs) program. This year the sponsor was the regional host, Metro, and included the McLoughlin Corridor in unincorporated Clackamas County. The project focused on economic development and high capacity transit in alignment with Metro's Economic Values Atlas project.

While one of our planners, Lorraine Gonzales, is involved with ISOCARP, the project is entirely separate from the county, and is being carried out by ISOCARP with the community. A verbal report on the project was presented at the ISOCARP conference on Oct. 26, and a written report will follow in about one month.

- 2. Voluntary mechanism to prevent up-zoning and/or dividing land in low-density residential neighborhoods The 2017-18 Long-Range Planning Work Plan includes a project to develop a voluntary mechanism to prevent up-zoning and/or dividing land in low-density residential neighborhoods (including, but not necessarily limited to, the Park Ave Station area). This mechanism is envisioned as a toolkit developed by the County that could be used by residents to work with their neighborhoods. Planning staff is researching options to make this happen and will return later this fiscal year with a proposal.
- 3. Grant application for Park Avenue Development and Design Standards project Another project in the 2017-18 Long-Range Planning Work Plan was to work with McLoughlin Area Plan Implementation Team (MAP-IT) to identify, scope and submit grant application(s) for a consultant for:

- a. Outreach on commercial and multifamily design and development standards, and residential protection
- b. Livability assessment of residential neighborhoods

The grant application was submitted to Metro on June 30, 2017, for \$180,000, and as this report is being written, the application is being recommended for full approval by Metro Council on its Oct. 26 agenda. Assuming the grant request is approved, we will move forward quickly with our MAP-IT partners to meet with Metro staff and begin the process of hiring a consultant.
