WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

This is an informational presentation which will provide an update regarding the progress of the construction project, the need for additional funding, and a request for support from the Board of Commissioners (possibly via letters of support) and a small amount of County Parks Department technical assistance in obtaining additional funding (possibly via grant proposal review).

EXECUTIVE SUMMARY:

The Columbia Land Trust, City of Lake Oswego, Clackamas County and numerous individuals have come together to plan, fund and construct a walking pathway along Rosemont Road. The County has provided assistance in preparation of the site (\$10,000, plus in-kind work), and has committed \$75,000 of its portion of Metro Local Share funds to the construction of the project. Lake Oswego prepared the section of pathway passing through their properties and has committed \$150,000 of its portion of Metro Local Share funds. In addition, the Oregon State Department of Parks & Recreation has awarded a \$130,000 grant. Multiple citizens have contributed countless hours and significant financial resources (\$52,000) to make this pathway a reality. Cooperation between both jurisdictions and citizens has been outstanding. In order to finalize construction, Columbia Land Trust (CLT) has loaned the project funds to finish the project. A grant could replace those funds. Private fundraising efforts are continuing as well.

PUBLIC/GOVERNMENTAL PARTICIPATION:

The only Board participation requested by Columbia Land Trust is support, possibly through letters of support for the project, in its fundraising efforts. Columbia Land Trust also requests a small amount of technical assistance, if needed, from County Parks to review any grants to raise further funding.

1. The Board can support or not support Columbia Land Trust in its efforts to secure additional funds to complete the project (possibly through letters of support).

2. The Board can recommend or not recommend that County Parks Department provide technical assistance to Columbia Land Trust in its pursuit of suitable sources of grant funding.


Impact on Operating Budget:
