


Department Mission, Vision, Core Values, Services




Departmental Structure




Departmental Budget Request



FY 2018-19 Proposed Budget





Key Performance Measures & Results aka...what you get for the money

- Community Corrections has developed a Strategic Business Plan and will implement Performance Clackamas fully in the following fiscal year.
- Justice Reinvestment grant funds have allowed the development of the Pretrial Program as well as expansion of our Corrections Substance Abuse Program (CSAP) and Short Term Transitional Leave (STTL) program.
- A Policy Analyst and new software programming have been added to aid in data collection.
- We are continuing to fund the Transition Center with carryover funds and looking for additional revenue streams to maintain services at the Transition Center.

Emerging Issues

Revenue trends:

- State revenue calculated biennially. Time study recently completed that will affect funding over the next six years. While future State revenue is unknown, it has been on the rise rather than decline.
- Justice Reinvestment funding applied for biennially.
 US Dept. of Justice grant application requesting funds to establish alternatives to incarceration for those affected by opioid addiction.
- Transition Center currently funded by carryover. Realignment of budget and external revenue contracts are being considered to ensure continuation of services.

Service demands:

Overall population growth is not affecting Community Corrections at this time. However, those affected by opioid addiction is expected to increase.

Capital needs:

- Residential Services property lease is set to expire in three years. We are currently working with County Counsel to renegotiate lease terms.
- No capital expenditures are expected beyond FY1819 paving and remodeling projects to facilitate our expanded treatment program at Residential Services.
