## Appointed Boards and Commissions (ABCs) Recommendation

The Water Environment Services Advisory Committee (WESAC) of Clackamas County, staffed by the Department of Water Environment Services, recruited for four seats.

The following seats had an expiring term date of December 31, 2023. The position was recruited with a term that runs from January 1, 2024, through December 31, 2026 (three-year term):

- 1 representative from the unincorporated Clackamas County community
- 1 representative from the ratepayers (Gladstone) community
- 1 representative from the ratepayers (Oregon City) community
- 1 representative from the business community

We had no vacant spots from members departing from their seats before term expiration.

On November 2, 2023, the recruitment took place by press release, social media, county website, and various other local media. The recruitment closed on November 23, 2022. Through this recruitment process, four applications were received and each qualified for the vacant seats they applied for.

Greg Geist the WES Director reviewed the applications and has formed the below recommendation.

The recommendation is as follows:

- Rita Baker, unincorporated representative, term to expire 12/31/2026
- Christopher Bowker, ratepayer (Gladstone), term to expire 12/31/2026
- William Gifford, ratepayer (Oregon City), term to expire 12/31/2026
- Christina Brow, business representative, term to expire 12/31/2026

The Board of County Commissioners could select other candidates or require further recruitment.
