

Appointed Boards and Commissions (ABCs) Recommendation

The Clackamas County Community Health Council, under the Health, Housing and Human Services Department, opened their recruitment for consumer and non-consumer representation. The Community Health Council has a federal grant requirement to maintain a majority of consumer members, and its by-laws require a minimum of nine members. This ABC holds a current roster of 9 members.

Members voted unanimously at the regularly scheduled meeting on May 15th 2024 to recommend to reinstate member, Michelle Walch, to serve her Second term on the council.

Michelle is a community member who has a personal interest in public health. She is interested to see how the council handles rural communications.
