**EXECUTIVE SUMMARY:** The Social Services Division of the Health, Housing and Human Services received ARPA Grant Funding. This revenue is appropriated by the State of Oregon, the Department of Human Services, and the Office of Developmental Disability Services.

This appropriation from the State of Oregon provided ARPA grant funding to the Social Services Division’s Developmental Disabilities program to purchase and distribute equipment and supplies to prepare for future emergencies among individuals with intellectual and/or developmental disabilities. The grant funds will support readiness and preparedness for everyone in the DD system, regardless of what setting they are in. Funding may be used to:

- 1) Purchase generators for residential homes or family homes where continuous access to power is necessary for ventilators and other critical medical equipment
- 2) Provide emergency survival kits for people in services
- 3) Foster connections between Intellectual/Developmental Disability providers and local Emergency Response units
- 4) Training in multiple languages for people with an Intellectual/Developmental Disability and families on emergency

**Whereas**, the Clackamas County Board of County Commissioners (the “Board”) has authority to sign all contracts and any amendments or renewals of the same;

**Whereas**, Oregon Revised Statutes (“ORS”) chapter 279A.200-220 and Local Contract Review Board Rule C-046-0400 permit Clackamas County to purchase goods or services using a cooperative procurement;

**Whereas**, the State of Utah via OMNIA Partners established a cooperative contract, contract #MA3457 (the “Contract”), with Amazon.com Services LLC for the online purchase of various goods and services;

**Whereas**, the Clackamas County Department of Health, Housing, and Human Services desires to purchase the following: 375 Eco Flow River Powerbanks at \$480.00 per kit, 100 Eco Flow Delta 2 Powerbanks with Solar Panels at \$1,100.00 each, 100 Westinghouse WGen9500DFc Generators at \$1,450.00 each, and 100 Impacca 5,000 BTU Window Air Conditioners at \$149.00 each, through the Contract, for a total contract price of \$449,900.00;

**Whereas**, the Clackamas County Department of Finance requests authority to utilize the Contract to purchase the aforementioned equipment by issuance of a purchase order (“PO”);

**Whereas**, a PO is issued directly through the Department of Finance’s management software with no signature required or available;

**NOW THEREFORE, the Clackamas County Board of County Commissioners resolves as follows:**

1. The requested use of the Contract to purchase the aforementioned equipment in the amount of \$449,900.00 is hereby approved;
2. The Clackamas County Department of Finance is hereby delegated limited authority to issue a PO to purchase the aforementioned equipment using the Contract.
