BACKGROUND:

In 2015 and 2017, Oregon Revised Statutes (ORSs) were updated to reflect the passage of House Bills (HB) 3100 and 2310, Public Health Modernization. HB 3100 required changes to increase the efficiency and effectiveness of the public health system across Oregon and ensure a base level of public health services to every person in Oregon. HB 2310 further clarified how the foundational capabilities and programs are to be implemented. These administrative changes more accurately reflect the current role of Local Public Health Authorities (LPHAs) in protecting and promoting the public’s health.

The Clackamas County Public Health Division and County Counsel recently conducted a review of local public health-related Board Orders and identified the need to update the referenced ORSs noted in Clackamas County Board Order #2015-79, In The Matter of the Clackamas County Board of County Commissioners, Acting as the Local Public health Authority and the Board of Health Ex Officio, Appointing a Local Public Health Administrator.

There are no substantive changes to this Board Order being recommended. This updated version only updates references to the current ORSs. The Board Order still appoints the Public Health Services

Director position as the acting Local Public Health Administrator. The Board of County Commissioners continue to serve as the governing body of the LPHA.

RECOMMENDATION:

Staff recommend that the Board of County Commissioners approve the revised Board Order, acting as the Board of Health for Clackamas County.

Section 2: The Local Public Health Administrator shall have all the authority granted that position by Oregon law.

WHEREAS, ORS 431.260 (7) provides that the governing body of the County is the Local Public Health Authority; and ORS 431.410 provides that the governing body of the County shall constitute a Board of Health ex officio; and

WHEREAS, ORS chapter 431 authorizes the Local Public Health Authority or the Board of Health of the County to appoint a Local Public Health Administrator;

WHEREAS, the Board of County Commissioners finds that it is the best interest of the County to appoint a Local Public Health Administrator;

NOW, THEREFORE IT IS HEREBY ORDERED:

Section 1: The Clackamas County Board of County Commissioners, acting as the Local Public Health Authority and the Board of Health ex officio, hereby name the Clackamas County Public Health Division Director as the Local Public Health Administrator for Clackamas County.

Section 2: The Local Public Health Administrator shall have all the authority granted that position by Oregon law.
