WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

Informational update on the work of the Oregon Field Office of the US Department of Housing and Urban Development. No Board action is requested.

EXECUTIVE SUMMARY:

The US Department of Housing and Urban Development is organized into 10 regions, with field offices in each state responsible for implementing HUD initiatives in their assigned area. Oregon is part of Region X, which includes Washington, Idaho, and Alaska. HUD facilitates a mortgage insurance program to developers and homebuyers, rental assistance through funding to local public housing authorities and private landlords, including the Housing Authority of Clackamas County, grants for housing and community development programs, including work undertaken by the County's Department of Health, Housing, and Human Services.

Within Clackamas County, HUD provides approximately \$11.6M in funding through the Housing Authority of Clackamas County, the Continuum of Care Program, and Community Development Grants, as well as 19 HUD-assisted private multifamily properties and other services provided by the County's Department of Health, Housing, and Human Services. Additionally, HUD has funded \$4.55M in projects through the Community Project Fund.

Challenges



When compared with all other states Oregon is...

- <u>#2</u> largest absolute increase homelessness from 2020-2022 was in (California, Oregon, Tennessee)
- <u>**#1</u> % of 'People in Families with Children who are Unsheltered'**</u>
- <u>**#1</u>** homeless persons that have 'chronic patterns' was in Oregon (44%)</u>
- <u>**#9</u> % of income spent on rent** (25.01%)</u>

Successes



- Clackamas County's 2023 count shows a significant reduction in the number of people experiencing homelessness
- The 2023 count found 410 people experiencing homelessness in Clackamas County, a decrease of 31.3% from last year
 - ➢ 45.3% decrease in the unsheltered population
 - ➤ 14% decrease in the sheltered population
- 6,500 residents served through homeless prevention and housing programs
- Street outreach program integrated with mental health and substance abuse treatment systems

HUD Funding in Oregon



Mortgage insurance - provides credit enhancements for home buyers and for multifamily developers. The insurance results in additional private investment exceeding \$4 billion in recent years.

Rental Assistance - makes housing affordable for the very lowincome. HUD contracts with local public housing authorities and private landlords to provide housing under the Low-Income Public Housing, Section 8 Vouchers, and the Section 8 project-based programs.

Grants - for housing and community development activities. HUD awards grants to tribal, city, county, state government, and non-profits. Awards are made either by formula distribution or by competitive process.





HUD's Multifamily Portfolio










CoC Performance Profile OR-507 Clackamas County CoC

Proportion of Housing First Projects by Year⁺


