Rebates offered for local businesses to protect the Clackamas River

lackamas River Water Providers (CRWP), in partnership with Water Environment Services (WES), is offering cash rebates and free technical assistance to help local businesses upgrade spill prevention equipment and protect the Clackamas River. The Clackamas River is a vital source of clean, safe drinking water for over 300.000 customers in Clackamas and Washington counties.

"Hazardous spills from commercial, industrial, and transportation activities can pose a significant risk to our drinking water source," said. Kim Swan, the Water Resource Manager for the Clackamas River Water Providers. Numerous businesses use and store hazardous materials within the Clackamas Industrial Area, which is east of I-205 near highway 212 and 224 corridor. This is of particular concern, since many facilities are less than a quarter of a mile away from the river. Spills can travel quickly to the river or small tributary creeks entering just upstream from four drinking water intakes.

CRWP is providing eligible businesses with 50% off the cost to purchase and/or install secondary containment equipment, up to \$1,000. Equipment may include spill kits, spill pallets, double walled tanks. repairs to floor drains, installation of shut-off valves, and construction of berms. Businesses must be located in the Clackamas Industrial Area and up-stream from Clackamas River Water Providers' drinking water intakes. Pro-

In addition to cash benefits, CRWP has partnered with the Pacific Northwest Pollution Prevention Resource Center

(PPRC) to provide free technical assistance and vol-

PPRC is the Northwest's leading source of high quality pollution prevention information, technical assistance. and training. PPRC works collaboratively with business and other organizations to promote environmental protection through pollution prevention.

Many storm drains are connected directly to the Clackamas River. When chemicals spill on a property or street, they travel to the river quickly. Only rain water should go down the storm drains.
