WHAT ACTION ARE YOU REQUESTING FROM THE BOARD? Approval to rename the urgent walk-in clinic, currently Centerstone, to Riverstone.

EXECUTIVE SUMMARY: Approximately a year ago, Clackamas County was contacted by Centerstone, a national for-profit mental health provider, asking us to cease and desist the use of the name "Centerstone" as they hold the federal trademark for the name. This was confirmed by county counsel and we have spent the last year working with stakeholders on the name. After much discussion, we are proposing the name "Riverstone". No-one has the trademark and we feel like the name is benign enough to not raise concerns but close enough to the old name that we can easily rebrand and remarket the new name.

FINANCIAL IMPLICATIONS (current year and ongoing): We set aside budget funds in the amount of \$38,000 for FY 16-17 in anticipation of the cost of the new name including marketing materials and a new sign outside of the clinic at the Ross Center.
