WHAT ACTION ARE YOU REQUESTING FROM THE BOARD? CCEM staff are requesting a commitment from up to two members of the Board of County Commissioners (BCC) to attend the IEMC April 13 – 16, 2015. Travel days are April 12 and 17.

EXECUTIVE SUMMARY: CCEM applied for the IEMC, with permission from the County Administrator, in December 2013. CCEM received notice of acceptance for the IEMC in April 2014 and notified the BCC soon after the notice of acceptance.

The IEMC is an exercise-based training course that will place emergency operations centers (EOC) personnel from our communities in a realistic crisis situation within a structured learning environment. Clackamas County has chosen a recovery scenario after a significant earthquake in the region. In preparation of the exercise CCEM invited stakeholders and partners to three table-top exercises this fall. The exercise topics were: fuel allocation, debris management, and rapid structural safety evaluation (damage assessment) of County facilities.

The IEMC exercise will cover the above topics as well as mass care/housing, mass fatalities, policy related to disasters at the city, county, state and federal levels, public information, as well as other components of a disaster and decisions and policy that are needed at all levels of government.

Clackamas County can have up to 75 attendees attend the course, which are to include chief elected and appointed officials from county and incorporated cities as well as representatives from law enforcement, fire, emergency medical services, public health, public works, etc. The exercise takes place at the Emergency Management Institute (EMI) in Emmitsburg, MD April 13 - 16, 2015.

FINANCIAL IMPLICATIONS (current year and ongoing): There are no on-going costs. The cost to this fiscal year is per diem for each county employee attending the course.

LEGAL/POLICY REQUIREMENTS: None

PUBLIC/GOVERNMENTAL PARTICIPATION: Participation from the county administrator, up to two members of the Board of County Commissioners, and several county employees.

OPTIONS: Board of County Commissioners can send up to two commissioners to participate in the exercise.

**RECOMMENDATION:** CCEM suggest sending two county commissioners to the IEMC.
