Values:


- Keeping youth connected to their home communities while maintaining safety for victims and the public

Services:

Lines of Business were created to be in alignment with the purpose clause of the Juvenile Delinquency Code of the Oregon Revised Statutes (ORS). ORS 419C.001 states:

"...The system is founded on the principle of personal responsibility, accountability, and reformation within the context of public safety..."

 - **\$169,973**
