## Appointed Boards and Commissions (ABCs) Recommendation

The Timber Sale Advisory Committee (TSAC), staffed by the Department of Transportation and Development's Forestry program, currently has two openings on their commission. Both openings were created by TSAC term expirations of two Forest Advisory Board members. The TSAC is comprised of two members of the Forest Advisory Board (FAB), two members of the County Parks Advisory Board (PAB), and one member at large representing the community in which the proposed timber sale will take place. The committee only convenes when there is a proposed timber sale and public process to consider. The FAB and PAB boards nominate and refer two of their members to fill positions on the TSAC. Members serve four year terms.

The FAB met on December 6, 2022, and Brent Keller and Dan Green expressed interest in serving another term on the TSAC. The FAB held an election and Mr. Keller and Mr. Green were approved to serve. Mr. Keller is a Professional Forester with over 30 years' experience and currently works as a consulting forester for a firm in Portland. Mr. Keller has been a member of our Forest Advisory Board since 2005. Mr. Green is a retired Professional Forester with more than 40 years' experience in the field. Dan also held the position of County Forester for seven years, and served on the Forest Advisory Board when the County first established the program in 1977. Mr. Green's has currently served on the FAB since April 2017.

Public recruitment did not take place since the vacant positions are designated for FAB members in good standing.
