

# Appointed Boards and Commissions (ABCs) Recommendation

The Community Road Fund Advisory Committee (CRFAC), staffed by the Department of Transportation & Development, currently has eight openings due to term expirations and resignations. Fifteen members are allowed with three-year terms; since this is still a fairly new ABC, terms are staggered to ensure a revolving membership in the future.

Recruitment opened to the public on June 24, 2021 and closed on July 12, 2021. Recruitment took place by press release, Facebook, Nextdoor, the county website, and notice to county CPOs and Hamlets. Through this recruitment process, 15 applications were received and seven are recommended to be appointed. Eleven applicants are new and four applicants just completed their terms on the Committee. All eligible applicants were contacted and interviews were conducted with applicants who responded.
