WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

1. Provide Pleasant Avenue Veteran Housing project update.

- 2. Requesting approval to place the Housing Assistance Payment (AHAP) contract with NHA for 24 Project Based Vouchers (PBV) for the Pleasant Avenue Veteran Project, on the June 21st HACC Board Consent Agenda.
- 3. Requesting approval to place the Development Agreement between Housing Authority of Clackamas County and Northwest Housing Alternatives (NHA), on the June 21st HACC Board Consent Agenda.
- 4. Requesting approval to place the Housing Assistance Payment (AHAP) contract with NHA for 7 Project Based Vouchers (PBV) for their campus redevelopment project on the May 17th Board Consent Agenda.

BACKGROUND:

Pleasant Avenue Veteran Project

According to the Homeless Point in Time Count conducted in the winter of 2017, there were 85 veterans found living without safe, decent and affordable housing. Numbers like these are in line with national trends showing that roughly one in ten people experiencing homelessness are veterans. As a direct response to this issue, Northwest Housing Alternatives has agreed to partner with the Housing Authority to construct 24 new apartments for Clackamas County veteran families. This proposal is modeled after the successful completion of a similar housing project in Washington County called Pomeroy Place.

Located at 314 Pleasant Avenue in the heart of Oregon City, the Pleasant Avenue Veteran Housing project will contain 24 units composed of studios, one and two-bedroom units and an ample community room that will host resident gatherings and allow for the provision of services. Units will be built with environmentally efficient and durable materials. There will be a peaceful landscaped outdoor area lying beneath the canopy of a protected heritage white oak that is a focal point of the site. The buildings will be oriented and wired to be solar-ready. When

complete, the project will be a community asset for Clackamas County that will be owned and operated by the Housing Authority of Clackamas County. To ensure that these units are affordable HACC has dedicated 24 PBV to the project. This ensures that the units will be affordable to families at or below 30% AMI.

The financing of the project is unique as it does not rely on Tax Credits. It uses a mix of CDBG, HOME, OHCS Veteran Grant, Project Based Voucher (PBV), Meyer Memorial Trust funds and Home Depot Foundation funds.

NHA will be responsible for development of the project. After stabilization (the point where the units are leased and the funding requirements have been met) NHA will transfer ownership of the project to the HACC. As the owner HACC will be able to implement a Housing First (low barrier) model to ensure that the neediest veterans and their families are assisted. HACC will be responsible for property management and maintenance. This will be done in-house and will not require hiring additional staff. HACC will also be responsible for ensuring services are available at the property. Services will be solicited through a competitive RFP process.

NHA Campus Redevelopment

The NHA campus is located at 2316 SE Willard St, Milwaukie, OR 97222. Based on their master plan, when complete, the campus will provide a development and management office, a new eight unit family shelter, and 28 multifamily affordable housing units, ranging between one and three bedrooms.

On October 20, 2016, the HACC Board approved a resolution awarding 5 Project Based Vouchers (PBV) to this project. The Housing Assistance Payment (AHAP) has been modified to increase the number to 7 PBV's.

Pleasant Ave Veterans' Project



About Pleasant Avenue Veterans' Housing

Pleasant Avenue will provide housing for veterans at or below 30% of the area median income. Home to the third largest veteran population in the state, Clackamas County has a long established goal to serve veterans and end veteran homelessness. Pleasant Avenue Veterans Housing is a 24-unit, fully subsidized project, serving chronically homeless and severely low-income veterans and their families. Located in the heart of Oregon City, directly between HACC and Clackamas County Veteran Services offices, the site is near resources for veterans and their families including community amenities like transit, grocery stores and health care providers.

The project was awarded as part of an innovative design process, under Meyer Memorial's Affordable Housing Initiative, Cost Efficiency/Innovative Strategy.

When complete, HACC will take on operations and resident services for the property. As the primary veteran services source for Clackamas County, HACC is uniquely positioned and equipped to ensure residents are provided the best opportunity to succeed and remain housed.
