VI. Reports – Regional Date DASHBOARD OVERVIEW

- -Input welcome through the ELED contact Sarah Comstock or Crime Prevention's Sara McClurg.
- -Three tabs at top are just a starting point. Hover over top right for instructions. Dashboard set up as what is happening, when it is happening and where it is happening.
- -Total at top right is the number of filtered calls. Filter when arrive on page is all calls in ELED year to date Jan-Feb. Wont see March until next month. Dada updated once a month, one month after the period.
- -Reset button located down at the bottom.
- -Brandenburg: Spoke about public initiated vs deputy initiated; ideally 60% vs 40%.
- -Time Matrix shows all days of the week in shaded color and the darker the colors, the heavier the level of crime.
- -Priority Scale Filtration discussion is located underneath the color matrix.
- -Map explanation. Hexspin map made of hexigons representing approximately one square block within the ELED.
- -Color/Health map: the brighter red vs blue means the higher call volume. This can filter out top 5 outliers using drop down at bottom left. This will give you a better sense of what you are looking at. You can also filter out top 5 busiest locations.
- -You are able to download the previous year's call records. Generates CSV file for you to download using Excel on your computer. No identifying information on the data downloads.
- -Greater County map uses same color ramp. Used chunks on land called "land areas". Most of these are also CPOS, but not all.
- *When site goes live in next couple weeks, we will e-mail ELED to provide link.
- -Phase II will be crime database. This information is from CAD.
