PARK AVENUE COMMUNITY PROJECT

Advisory Committee: Valerie updated

Eighteen people in advisory committee. Met to get to know each other. Staff went over the RFP/Evaluation process with the Evaluation Committee after the Advisory Committee meeting. Working on getting representation from young families and multi-family units. Next meeting TBD.

SUBCOMMITTEE REPORTS

Residential Infrastructure Planning

Subcommittee is without chair since the departure of Terri Gibson. Joseph Edge has volunteered to be the acting chair.

On Joseph's behalf (who could not attend MAP-IT meeting), Karen summarized discussion with North Clackamas Watersheds Council executive director on addressing MAP priority to identify

strategies for preserving existing natural areas and habitat. One idea from that was to bring together similar groups for a one-time event to discuss ideas and identify strategies for natural resources. MAP-IT members discussed other ideas, too, and the topic was referred back to the subcommittee for further discussion and proposal development.

Pedestrian & Bike Safety – Fred Sawyer

Fred attended the Policy Advisory Committee. The committee approved 3 of the 10 Oak Grove/Lake Oswego pedestrian bike bridge alignments. Metro asked to do a study for a transit bridge option for the bridge.

Mitra reported on Safe routes to school project: county received grant to hire a safe routes to school coordinator. Will apply for grant in spring when plan/proposal is complete. Grant information will be completed by next fall. The grant needs to have a minimum 20% match. The grant is for \$2 million.

Communication, Outreach & Events – Terri Gilreath & Karen Bjorklund

August Trolley Trail event— had large volume of traffic at first ever 3-partner booth (plus MAP-IT). Received many new contacts for interested community members for various partner organizations and MAP-IT, and some people interested in being volunteers. Created many communication pieces for booth that can be used in the future.

Commercial Planning & Design

In addition to current activities, subcommittee members will aid Residential Infrastructure Subcommittee with discussion on strategies for natural resource preservation. (Full subcommittee report from Joseph at next meeting.)
