This Amendment #2 is entered into between **Mark43, Inc.** (“Contractor”) and Clackamas County (“County”) and shall become part of the Contract documents entered into between both parties dated as of **October 26, 2017** (“Contract”).

The Purpose of this Amendment #2 is to make the following changes to the Contract:

1. ARTICLE I, Section 1. **Effective Date and Duration** is hereby amended as follows:
By execution of this Amendment #2, the County hereby exercises its second optional annual renewal. The Contract expiration date is hereby extended from December 31, 2023, to **December 31, 2024**.

2. ARTICLE I, Section 3. **Consideration** is hereby amended as follows:
In consideration for Contractor performing Work during the second extended term of this Contract, County shall pay Contractor’s reseller, Insight Public Sector, Inc., an amount not to exceed \$212,506.40, further described in **Exhibit A** to this Amendment #2, attached hereto and incorporated by reference herein. The total Contract compensation shall not exceed **\$1,431,495.44**.
