

Year Two: \$50,000 County Investment

8 participants have received training through Oregon BOLI Registered Pre-apprenticeship Program

Continued funding at the same or higher levels would benefit from:

- In addition to the individuals served through the investment of Clackamas County, our providers were able to leverage resources and support the placement of 8 people in construction trades jobs, with an average starting wage of \$24.34 in program years 2021 and 2022
- Increased number of woman and people of color accessing high paying construction careers

To: Clackamas County Board of County Commissioners RE: Budget for Fiscal Year 2023-2024

Attached for your review is a budget for the July 1, 2023 – June 30, 2024, fiscal year. This budget has been reviewed and approved by the CWP Executive Committee and full Board of Directors.

Budget Notes

- 1. 69% of total planned expenditures goes directly into the community through contracts with direct service providers and the One-Stop Operator.
- 2. New funding is currently \$245,000 less than the current year's approved budget, a 5% decrease.
- 3. The state received an overall 8% decrease in WIOA formula funds allocations for FY23/24. CWP received a 12% decrease in WIOA funding.
- 4. WIOA formula expenditures make up 39% of the budget, 14% from Prosperity 10,000 ARPA funding, and 25% from Clackamas County Capacity Building Recovery Assistance.
- 5. CWP has \$1,900,000 in awarded funds designated for future periods, including future years of multi-year state grants, and WIOA carry forward funds.
