Use of Force Annual Report 2020

Overview

At the Clackamas County Sheriff's Office, we invest in hiring people who have the right temperament for public safety work with backgrounds that demonstrate good decision making. Fewer than 4% of applicants are hired. Typically, it takes eighteen months of training from the date of hire to the day a Deputy Sheriff begins their independent assignment. Then, throughout their career, professional training and on-going performance evaluation continue. These standards are among the ways we ensure we have a professional workforce capable of making the best decisions in the field.

Each day in carrying out their duties our deputies are involved in numerous and varied interactions with the people they contact. When resistance occurs, we expect our deputies to use their skills and abilities to safely and effectively resolve confrontations and minimize the need to use force whenever reasonably possible. To ensure this capacity, our deputies receive monthly training by certified instructors on all categories of force and de-escalation techniques.

Our commitment to public safety emphasizes respect, professionalism and the protection of human life, even when force is necessary. In the use of force to effectively gain control of a situation, deputies are trained to use force only when it is objectively reasonable under the totality of circumstances known to the deputy, and to the degree the deputy believes necessary to effect an arrest, prevent an escape, or protect life. Deputies are trained to continually evaluate the situation in an application of force, and to render first aid as needed. Every deputy is required by Sheriff's Office policy to intervene in a fellow law enforcement officer's use of force when they believe a use of force is unjustified or excessive.

The Sheriff's Office recognizes the degree of responsibility that comes with the authority to use force and the obligation to be accountable for its proper use. Toward that end, the Sheriff's Office requires every use of force to be accounted for and justified. As required by Sheriff's Office policy, following a use of force, a deputy must complete a Use of Force Report documenting and explaining why force was used, the nature of the force, and the outcome. All Use of Force Reports are reviewed by supervisors to determine whether the deputy's actions were justified and within policy. Reports are also reviewed by command staff to ensure consistency in practices throughout our agency and to inform continued training.

We recognize that police use of force is a matter of critical public concern and that transparency in use of force practices is essential to community trust. The intent of our Use of Force Annual Report is to aid the public in understanding our practices by providing transparent and accountable information. The data presented in this report is derived from our 2020 Use of Force Reports. 

Reported Injuries

Subjects reported 92 injuries. About 90% of the reported injuries were abrasions/lacerations. Deputies reported 19 injuries.



Case Number: 20-007747

Number of Deputies Involved: 3

District: 99/McLoughlin

On April 11th, 2020 at about 10:05 p.m., deputies were dispatched to a domestic disturbance. The caller reported her husband was armed with a firearm and stated she was hiding inside the residence with her son. Upon arrival, deputies believed they heard a gunshot come from inside the house and entered the residence. Deputies were then confronted by a male suspect holding a shotgun. Deputies ordered the suspect to drop the shotgun, instead he raised the shotgun toward them. Deputies used lethal force on the suspect and he was pronounced dead at the scene. No deputies were injured in the event.

Case Number: 20-025383

Number of Deputies Involved: 6

District: West Side

On November 27th, 2020 at about 9:03 p.m., deputies were dispatched to a domestic disturbance. The caller reported her husband had shot at her inside the residence and then went outside. When the deputies arrived, the male suspect was outside the residence holding a shotgun and making suicidal statements. The suspect fired his shotgun as he lowered it toward the deputies. The deputies used lethal force on the suspect and he was pronounced dead at the scene. No deputies were injured in the event.
