

Appointed Boards and Commissions (ABCs) Recommendation

The Milwaukie Community Center Advisory Board, is staffed by the North Clackamas Parks and Recreation District/Milwaukie Center, and elected board members. The advisory board had 3 openings on their commission due to one board member resignation and two term expirations. Eleven members are allowed with 3-year terms.

Recruitment opened to the public on October 17th, 2022 and closed on October 31st 2022. Recruitment took place by press release, Facebook, and the Clackamas County website.
