STATEMENT OF RIGHTS

- 1. Prior to the Hearing. You have the right to make the following requests:
 - (A) You can request the opportunity to review public records and to talk to County staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
 - (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
 - (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. Procedure. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence, the burden is on the County to establish by a preponderance of the evidence that a violation exists, or existed. Either party may, at their own expense, obtain an attorney to represent them at the hearing. If you wish to be represented by an attorney they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question the parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. Record of Proceedings. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. Hearings Officer. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence, and interpret and apply the law. After the hearing is closed the Hearings Officer will enter written findings of fact, conclusions of law, and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a Final Order or Continuing Order. The Hearings Officers Order is the final decision of the County, and may be appealed pursuant to Oregon law. - 5. <u>Right to Recess</u>. If, during the course of the hearing, Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceeding be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- 6. <u>Right to Appeal</u>. The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearings Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, appellant is responsible for all costs of appeal including preparation of transcript.

COMPLAINT AND REQUEST FOR HEARING

I, Jennifer Kauppi, Code Enforcement Specialist for Clackamas County, allege the following:

1.

Respondent mailing address is: 14805 SE 187th Ave, Damascus, OR 97089

The address or location of the violation(s) of law alleged in this Complaint is: 14805 SE 187th Ave, Damascus, OR 97089 also known as T2S, R3E, Section 08B, Tax Lot 00712, and is located in Clackamas County, Oregon.

3.

On or about the 9th day of December, 2021 the Respondent violated the following laws, in the following ways:

a. Respondent violated the Clackamas County Building Code, Chapter 9.02.040 by failing to obtain approved permits and approved final inspections for a remodel to a single family residence. This violation is a Priority 1 violation pursuant to the Clackamas County Violation Priorities.

Page 1 of 3 – COMPLAINT AND REQUEST FOR HEARING

The Department initiating this procedure is the Code Enforcement Section of the Department of Transportation and Development.

Notice of the violations was given to Respondent in the following manner: Administrative Citation #0044820-1 in the amount of \$100.00 was mailed via first class mail on December 9, 2021. A copy of the notice document is attached to this Complaint as Exhibit G, and incorporated by this reference.

6.

Based on these allegations, petitioner requests that a hearing be set in this matter.

Petitioner seeks an Order from the Hearings Officer granting the following relief:

- 1. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to immediately abate the violation and bring the property at issue into compliance with all laws, and permanently enjoining Respondent from violating these laws in the future;
- 2. Pursuant to Clackamas County Code Section 2.07.090, imposing a civil penalty against Respondent for each violation, within the range established by the Board of County Commissioners. Said range for a Building Code Priority 1 violation being \$750.00 to \$1,000.00 per occurrence as provided by Appendix B to the Clackamas County Code
- 3. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to pay an administrative compliance fee as provided by Appendix A to the Clackamas County Code;

4. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondent to reimburse the County for any expense the County may incur in collection of any penalties, fines or fees that may be imposed:

History of Events and Exhibits:

December 9, 2020 Clackamas County received a complaint regarding 2 metal accessory

structures over 200 square feet in size and a remodel to a single family

residence without permits.

December 14, 2020 Correspondence was sent to the Respondents regarding the alleged Building

Exhibit A Code violation.

December 17, 2020 The Respondent contacted Code Enforcement Specialist Michael Barnes

regarding the alleged violation. The Respondent stated that her husband had passed away. He had converted a bedroom into a bathroom and remodeled the kitchen without permits. The Respondent also stated there were two accessory structures on site. One structure was approximately 120 square feet which had been sold. The other structure was approximately 400 square feet. There was no electrical in this structure and the Respondent was likely

going to be selling this as well.

December 23, 2020 Plumbing inspector Tom Miltenberger and electrical inspector Doug

Boettcher conducted a site inspection and found the property had both

plumbing and electrical work done that would have required permits.

December 28, 2020 Correspondence was sent to the Respondents with a deadline of January 28,

Exhibit C 2021 to abate the violation.

February 3, 2021 The Respondent was unsure what permits she needed to obtain for the work

that was done on site. Permit Technician Shirley Cass-Crosby emailed the

Respondent and provided the information on how to complete the

applications.

July 15, 2021 The Respondent contacted Michael Barnes stating that she had sent over the

plumbing permit in February but had not heard from us. In addition, she had not submitted the electrical application because she was waiting on an

electrician.

July 15, 2021 The Respondent resent the plumbing application to Shirley Cass-Crosby.

Exhibit E The permit application was incomplete.

November 5, 2021 Exhibit F	I emailed the Respondent regarding the violation stating that an electrical permit and plumbing permit still needed to be submitted. The Respondent contacted me by phone regarding the email and I resent permit information to her.
December 9, 2021 Exhibit G	I reviewed County records and found no permits had been applied for. I did confirm based on aerial images that the accessory structures had been removed. Citation 0044820-1 was issued for \$100.00 for the Priority 1 Building Code violation and sent first class mail. The first class mail was not returned and this citation remains unpaid.
December 17, 2021 Exhibit H	Electrical permit E0850621 was issued. This permit received an approved final inspection on October 17, 2022.
January 17, 2023 Exhibit I	Correspondence was sent to the Respondent with a deadline of March 1, 2023 to abate the Building Code violation.
March 13, 2023	I conducted research in the County permit system. The required permits had not been obtained and this matter was referred to the Hearings Officer.

If the Compliance Hearings Officer affirms the County's position that a violation of the Building Code, Title 9.02.040, the County may request a Continuing Order in this matter recommending the following:

- The Respondent be ordered to bring the property into compliance with the building code within 30 days of the date of this order by submitting or having a professional submit a complete plumbing application for the remodel of the kitchen and new bathroom. Respond to all requests for additional information within 10 days of being notified. The Respondent be ordered to pay for permits within 10 days of being notified permits are ready to be issued and must complete all required inspections including approved final inspections within 45 days of permit issuance.
- Code Enforcement to confirm compliance of the above item and the County will submit a Post Hearing Status Report. The report will be sent to the Compliance Hearings Officer and to the Respondent.
- The report may include the following recommendations:
- The imposition of civil penalties for the Building Code violation of up to \$1,000.00 for date cited December 9, 2021.
- Payment for Citation No. 0044820-1 issued on December 9, 2021 for \$100.00.
- The administrative compliance fee to be imposed from December, 2020 until the violation is abated. As of this report the total is \$1,950.00.
- The County requests the Hearings Officer to permanently prohibit the Respondent from violating this law in the future.
- If the Respondent fails to comply with the Hearings Officer's Continuing Order the County will request the Hearings Officer to issue a Final Order and will also request the Hearings Officer to authorize the County further enforcement action including to proceed to Circuit Court.

Code Enforcement spoke with property owner Julie on December 22, 2020 and she admitted there is an unpermitted structure exceeding 200 square feet. She also admitted electrical and plumbing had occurred in the kitchen and bathroom. Plumbing and Electrical inspectors from the Building Codes Division conducted an inspection of the subject property on December 23rd, 2020 and confirmed there was unpermitted electrical and plumbing. You are in violation of Chapter 9.02.040 (A, C, D) of the Clackamas County Building Code.

In order to abate the building code violations, please utilize one of the following options not later than January 28, 2021:

- Submit the building permit application(s), electrical permit, plumbing permit, and technically complete plans and appropriate fee(s)
 - o The permit must be picked up within ten days of being notified.
 - Please schedule all inspections so that final inspections may be obtained not later than 45 days of the date of the permit being issued. Or:
- Obtain a demolition permit for the structure(s).
 - o Remove all associated debris from the demolition not later than 45 days of the date of the permit.

Required Notice of Fines and Penalties

It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, (2) assessment of an administrative fee, and (3) referral of this matter to the County Code Enforcement Hearings Officer.

The Clackamas County Code provides for fine amounts of up to \$500 and additional civil penalties of up to \$3,500 for each day the county verifies the noncompliance. Fine amounts and civil penalties are assessed for each cited violation and may be assessed separately against each named party. In addition, the Code Enforcement Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.

Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may waive all or part of the \$75 per month administrative fee.

Unpaid fines, administrative fees, civil penalties and abatement costs may be recorded as a lien against property owned by any of the parties either jointly or separately.

Also, be advised that non-compliance with a Hearings Officer's Order may result in the matter being referred to County Counsel for legal action in Circuit Court which may result in additional penalties or other sanctions.

Finally, recurrences of abated violations will result in the issuance of a citation without prior notice.

The electrical permit will be for the additional circuits that were added in regards to the kitchen, master bedroom/bath for the house. The plumbing permit will need to have the additional fixtures that were added, so you would need to mark those. If you are still struggling, I am back in the office next week and you could come in and I could talk to you in person, but ultimately you will still need to complete the applications. SO for example if you added new fixtures in the bathroom that were relocated ever so slightly, then those fixtures would be added. If you for example removed a 1970's sink and replaced with a new one in exact same pot and connection, then you would not add it. I do not want to confuse you, so please let me know what works best.

So did you relocate just a bathtub in an existing bathroom or did you relocate a bathroom in a certain area? Also, again the description is fairly vague in regards to the kitchen remodel. You may not need a structural permit, but I am not sure based on what info I have available to me at this moment. Also, where then is the electrical permit, being there was also other work being done. A licensed electrician and plumbing contractr would need to apply for the electrical permit if this property is for sale.



 - The permit(s) must have the fee(s) paid in full within ten days of your being notified by Building Codes.
 - Please schedule all inspections so that final inspections may be obtained not later than 30 days of the date of receipt of your approved permit(s).

- Administrative Compliance Fees. It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. An administration compliance fee of \$75 will now be assessed monthly until the violations are abated.
- 2. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, and (2) referral of this matter to the County Code Enforcement Compliance Hearings Officer.
- 3. Request for a Hearing: If you dispute the existence of the violations described in the enclosed letter you may request a hearing before the Hearings Officer by sending a written request for a hearing, including your name and address to: Code Enforcement Section, 150 Beavercreek Rd., Oregon City, OR 97045, or at codeenforcement@clackamas.us.
- 4. **Potential Fines and Penalties:** The Clackamas County Code provides for Citation fine amounts of up to \$500 and additional civil penalties imposed by the Hearings Officer of up to \$3,500 for each day the County verifies the noncompliance. Fine amounts and civil penalties may be assessed for each cited violation and may be assessed separately against each named party. In addition, the Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.
- 5. **Voluntary Compliance:** Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may in its discretion waive all or part of the \$75 per month administrative fee.
