# FIRST READING OF AN ORDINANCE AMENDING CHAPTER 8.02, TRANSIENT ROOM TAX, OF THE CLACKAMAS COUNTY CODE AND DECLARING AN EMERGENCY.

Chapter 8.02 of the Clackamas County Code provides for the collection of a 6% transient room tax for occupants of a hotel. Section 8.02.060 exempts persons from paying the tax under certain circumstances, including where the rent is of a value less than \$10.00 per day. Clackamas County Code Section 8.02.060 (B).

Non-profit organizations often have lodges which are made available to members for a nominal fee. However, often that fee is more than \$10.00 per day, subjecting the non-profit group to the transient room tax in Chapter 8.02. Since non-profit groups run such lodges on a volunteer basis, collection of a transient room tax poses a substantial burden on the non-profit organization. It is in the public interest of the County to exempt such non-profit groups from paying the transient room tax. Therefore, County Code § 8.02.060 (B) should be amended to increase the exemption for paying the transient room tax to rents in excess of \$15.00 per day.

An emergency exists because the non-profit groups are being substantially burdened by having to collect and account for the transient room tax.

#### RECOMMENDATION

Staff respectfully recommends that the Board approve the attached amendment to Section 8.02.060 (B) of the Clackamas County Code to increase the exemption for payment of the transient room tax.

# ORDINANCE NO.

# An Ordinance Amending Chapter 8.02, Transient Room Tax, of the Clackamas County Code and Declaring an Emergency

WHEREAS, the current code exempts any person who pays rent of less than \$10.00 per day from payment of a transient room tax; and

WHEREAS, the public interest would be better served by raising the exemption value of rent to \$15.00 per day to enable non-profit organizations to provide lodging to their members without being subject to a transient room tax; now, therefore;

The Board of Commissioners of Clackamas County ordains as follows:

- Section 1: Section 8.02.060(B) of the Clackamas County Code is hereby amended to read as follows:
  - B. Any person whose rent is of a value in excess of \$15.00 per day;
- Section 2: Emergency Clause

The Board of Commissioners hereby finds and declares that an emergency exists inasmuch as the immediate effect of this Ordinance is necessary for the peace, health and welfare of the residents of the County. Accordingly, this Ordinance shall be effective upon its adoption.

# FIRST READING OF AN ORDINANCE AMENDING CHAPTER 6.06 – PARK RULES, RESOLUTION AMENDING PARK FEES (APPENDIX "A"), OF THE CLACKAMAS COUNTY CODE, AND DECLARING AN EMERGENCY

In an effort to enhance security in the county parks, staff feels it is necessary to modify the rules and regulations in Chapter 6.06 of the County Code regarding the possession of alcohol in county parks. The attached Ordinance sets forth the proposed changes.

Staff also recommends that the County Park fee schedule be updated so it is more consistent with other parks in the region. The County Parks division of Business and Community Services has completed a review of the Park Rules and Regulations and current fees.

Staff requests the Board declare an emergency and implement the Ordinance amendments effective February 25, 2010, due to the immediate need to begin taking reservations for the upcoming park season which begins May 1<sup>st</sup>.

County Parks is proposing an increase of \$5.00 per vehicle for day-use park entry, bringing the fee to \$8.00, and establishing a new commercial vehicle day-use entry fee of \$20.00. The current fee is \$3.00 for all vehicle types. Staff further recommends the day-use entry fee be collected seven days a week between May and September, rather than just on Saturdays, Sundays and holidays. An increase in the day-use season pass is recommended from \$30.00 to \$50.00 for non-commercial vehicles. It is further recommended a commercial vehicle day-use season pass fee be established at \$100.00.

County Parks is proposing an increase of overnight camping fees. Current fees are:

	Weeknights	Weekends	
Non-Electric campsite	\$12.00	\$16.00	
Electric/H2O campsite	\$16.00	\$19.00	

Staff recommends an increase to \$21.00/night for all campsites.

County Parks proposes an increase in the reservable picnic area rental fee of \$15.00 for noncovered areas, and \$25.00 for covered picnic areas. The attached fee schedule shows current and proposed rates by Park and area.

Amendments to the County Code are recommended which will ban the possession of alcohol in any County Park without a permit. At the BCC study session on January 12, 2010, the proposed amendments to the Park Rules and Regulations were approved for Public Hearing.

# RECOMMENDATION

County Parks' staff respectfully recommends that the Board read the Ordinance amending Chapter 6 of the County Code by title only, assign a number to it, and schedule it for a Second Reading and consideration of adoption on February 25, 2010.

Staff further recommends that the Board approve the attached Resolution modifying the County Parks fee schedule in Appendix "A" of the County Code. A table is attached to the Resolution indicating current prices for items/services and the recommended price increases. If approved, the fee changes will go into effect on February 25, 2010.

APPROVAL OF AN INTERGOVERNMENTAL AGREEMENT WITH THE LAKE OSWEGO SCHOOL DISTRICT (LOSD) AUTHORIZING THE COUNTY TO COLLECT A CONSTRUCTION EXCISE TAX ON LOSD'S BEHALF FOR ALL IMPROVEMENTS TO REAL PROPERTY WHICH RESULT IN A NEW STRUCTURE OR ADDITIONAL SQUARE FOOTAGE TO AN EXISTING STRUCTURE EFFECTIVE MARCH 1, 2010 AND ESTABLISHING TERMS AND CONDITIONS FOR THE AGREEMENT

In July 2007, the Governor signed legislation which authorizes a school district to levy a Construction Excise Tax (CET) on new construction if it elects to do so by resolution. If a school district elects to impose a CET, the tax is to be assessed on certain construction permits issued within that school district. The tax is to be used solely for the purpose of funding capital improvements which are defined in the bill.

The Lake Oswego School District has elected to impose a CET, which it intends to authorize by resolution on or after February 11, 2010. Prior to adopting such a resolution however, the school district must enter into an intergovernmental agreement (IGA) with local government which establishes collection duties and responsibilities, administrative fees to offset the costs of collection and other terms.

The tax will apply to building permits for any improvement to real property which results in a new structure or additional square footage in an existing structure beginning March 1, 2010. The tax will apply to both commercial and residential structures; however, these structures will be taxed at different rates. The tax will be assessed at the rate of \$1.00 per square foot for structures intended for residential use (including multiple-unit housing) and at a rate of \$0.50 per square foot for non-residential structures. The legislation provides for a cap on the amount of tax collected for non-residential structures of \$25,000 per building permit or \$25,000 per structure whichever is less.

The legislation charges local building departments with the responsibility to collect the tax at the time affected building permits are issued. The attached IGA outlines the negotiated scope and terms of the agreement. The agreement defines the method and frequency for reporting, how remittance is to be handled and establishes an administrative fee to offset the County's costs associated with the collection of the tax. The IGA also establishes how exemptions from the tax are to be handled and how those exemptions are to be reported.

#### **RECOMMENDATION:**

Staff respectfully recommends that the Board approve the attached intergovernmental agreement with LOSD which will authorize the Clackamas County Building Codes Division to collect a construction excise tax on LOSD's behalf for all improvements to real property which results in a new structure or additional square footage in an existing structure beginning March 1, 2010.

# APPROVAL OF REQUIRED NOTICE FOR THE PROPOSED TREE ORDINANCE

Prior to the first hearing on an ordinance that proposes to limit or prohibit land uses previously allowed, the County is required by ORS 215.503 to mail written individual notice to owners of the affected properties. In consultation with the Office of County Counsel, the Planning Division has determined that such a notice is required for the proposed tree ordinance. Based on the scope of the proposed ordinance, the notice will be mailed to owners of unincorporated County property inside the Portland Metropolitan Urban Growth Boundary. The statute requires that the notice must be approved by the Board of County Commissioners.

ORS 215.503 requires that the notice include substantially the following language in boldfaced type across the top of the face page extending from the left margin to the right margin:

"This is to notify you that Clackamas County has proposed a land use regulation that may affect the permissible uses of your property and other properties."

In addition, the body of the notice must contain substantially the following language:

"Clackamas County has determined that adoption of this ordinance may affect the permissible uses of your property, and other properties in the affected zone, and may change the value of your property."

The Planning Commission hearing on the tree ordinance is scheduled for March 22, 2010. The required property owner notice must be mailed between 20 and 40 days prior to the hearing. In order to meet the timelines for printing and mailing, Board approval is necessary at this time, or the Planning Commission hearing must be rescheduled.

In addition to providing details about the proposed tree ordinance and the Planning Commission hearing, the proposed notice announces the Board's hearing on the tree ordinance, scheduled for June 8, 2010, beginning at 6:30 p.m.

# Contract with and Appointment of Hearings Officer for County Personnel Code

Chapter 2.05 of the County Code, entitled "Personnel Policies and Procedures," provides that a Hearings Officer appointed by the Board of County Commissioners shall preside at certain hearings authorized by the Code. The authorized hearings relate to allegations of fraud or discrimination in the hiring process, or appeals of discipline or discharge by classified employees who do not have available a grievance procedure in a collective bargaining agreement. Few employees are in this category, as most are either in a collective bargaining unit, or are "unclassified" (at-will) employees, and thus do not meet the criteria for this type of hearing.

Timothy D.W. Williams was previously selected in a competitive process and appointed to serve as the Hearings Officer for the personnel code, however his contract and appointment has expired. The attached contract will reappoint him and grant a new contract. The hearings officer serves in an on-call capacity, and there is no expense unless a case is heard. In a typical year there are no cases heard under these provisions. Mr. Williams' firm is NorthWest Resolutions, Inc.

#### RECOMMENDATION

Approve the attached contract and appointment of Timothy D.W. Williams / NorthWest Resolutions, Inc. as hearings officer for the County Personnel Code.

# APPROVAL OF AN INTERGOVERNMENTAL AGREEMENT BETWEEN CLACKAMAS COUNTY TECHNOLOGY SERVICES DEPARTMENT AND THE CLACKAMAS COUNTY FAIR BOARD

The Department of Technology Services (TS) requests approval of the attached Intergovernmental Agreement with the Clackamas County Fair Board (Fair) for the purpose of providing Web Hosting resources and support to the Fair. This agreement provides the basis for a cooperative relationship between TS and the Fair. This is a new agreement by which TS provides an established scope of services and rates in the support of the Fair Webpage for the Fair.

The County Fair is looking for the County to host the Fair's Website and links as well as provide an internet connection for the website. The Fair would also utilize the County's Content Management Utility (Alfresco) to maintain the content of the website using Fair staff. The County would be responsible for maintaining the infrastructure (servers, network, database etc) required for the Fair to maintain their website. The County would also be available for training of Fair staff, assistance with technical issues and development of applications as requested by the Fair at the rates identified in the agreement.

If this agreement is approved, Technology Services has agreed to provide the specified services and resources. Development of this IGA began in November 2009 and the dates referenced reflect that time period however the Agreement becomes effective February 12<sup>th</sup>, 2010 and will automatically renew each year on November 1<sup>st</sup> unless requested to terminate by either party. Provided technical support would be charged for at the rates identified in the Agreement. Revenue from this Agreement will be added to the TS budget line 747-0216-00-341700.

#### RECOMMENDATION

Staff respectfully recommends approval of this Agreement and delegate authority to the Chief Information Officer to sign future amendments for additional work or service renewals for the County Fair as long as the requested work is less than \$25,000.
