## Appointed Boards and Commissions (ABCs) Recommendation

The Emergency Preparedness Council, staffed by the Disaster Management, currently has 18 openings on their commission due to the Emergency Preparedness Council being newly formed.

Recruitment opened to the public on August, 30 2021 and closed on September 24, 2021. Recruitment took place by press release, social media, county website, and support from community partners. Through this recruitment process, 74 applications were received and 18 are recommended to be appointed. 18 applicants are new and 0 applicants are currently on the board, as this is a new board. Applications were reviewed for lived and professional experience, geographic diversity, and diverse community perspectives. Tools used for review included supplemental questionnaires and interviews.
