WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

No Board request at this time. This is an informational presentation by the Metro Waste Prevention and Environmental Services team: Marta McGuire (Director) and Estee Segal (Principal Planner).

EXECUTIVE SUMMARY:

Metro has developed a draft Regional System Facilities Plan (RSFP) to guide investments in the region's reuse, recycling and garbage infrastructure. The RSFP assesses the current public, private, and non-profit garbage, recycling and reuse infrastructure, identifies gaps in services, and presents potential plans for future investments in new facilities or new services. The draft plan is available at https://www.oregonmetro.gov/sites/default/files/2024/12/31/Draft-Regional-System-Facilities-Plan-final.pdf

The RSFP presents a 20-year strategy and overviews investments in 4 key areas:

- **Community drop-off depots**. Establishment of six regionally dispersed community drop-off depots to accept noncommercial self-haul garbage, recycling, reuse materials, and household hazardous waste. The proposal includes transitioning Metro South into a community drop-off depot.
- **Reuse and repair**. New reuse and repair options including a warehouse space for reuse organizations, and development of a reuse mall to promote reuse and provide community access to upcycled and refurbished items.
- **Organics infrastructure**. Expanding the transfer and processing of organics (food waste, yard debris, clean wood), including making Metro Central an organics hub, and exploring public-private partnerships to develop additional hubs.
- *Metro South*. With Metro South proposed to transition to a community drop-off depot, the RSFP includes new investments in Clackamas County to provide commercial transfer services. The two proposals provided in the draft are using private transfer stations to accept commercial materials or building a new transfer station through a public-private partnership.

Over the life of the plan, the RSFP proposes large scale changes that will impact the entire region and is estimated to increase household garbage bills by \$1.50 to \$2.00 monthly if all investments are pursued. The Clackamas County Sustainability and Solid Waste program coordinates with franchise haulers and works in partnership with the Solid Waste Commission for proposing adjustments to garbage and recycling fees as adopted by the Board of County Commissioners.

As part of the Regional System Facilities Plan project, Metro provides presentations to governing bodies and stakeholders. As the RSFP will have significant impacts for the County and our residents, staff have invited Metro to provide a presentation for the Board regarding the Regional Systems Facilities Plan.

PUBLIC/GOVERNMENTAL PARTICIPATION:

Development of the RSFP began in February 2022, the draft plan was open for public comment in October 2024, and County staff submitted comments at that time. The newly formed Regional Waste Advisory Committee (RWAC) reviewed and provided feedback on the plan during their first two meetings in January and February. Currently Metro Council is scheduled to consider adoption of the RSFP in March of 2025.

Moving forward, the RWAC will be responsible for guiding the implementation of the plan and the related fee adjustments. Clackamas County does not hold a seat on the RWAC, but staff are coordinating closely with partner jurisdictions to stay engaged and advocate as future conversations are held regarding the Regional System Facilities Plan.

Regional System Facilities Plan Advancing Waste Reduction, Access and Affordability

The plan is a comprehensive, long-term vision and strategy for investing in reuse, recycling and garbage facilities and infrastructure across the region. The plan aims to reduce waste sent to landfills, increase access to facilities and services, and keep costs affordable.

People in greater Portland need better access to services in our reuse, recycling and garbage system. Beyond curbside collection, people need convenient and affordable ways to get rid of large items and hazardous waste. Today, some people have easy disposal options if they live close to a Metro transfer station, but many people in the region do not. And as the region grows, more investment is needed to ensure that everyone, no matter where they live, has equal access to reuse, recycling and garbage services.










