WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

This is an informational update only. Each month staff will update the Board on the collaborative strategic communication efforts of WES and PGA to raise stakeholder awareness regarding the need to build additional solids handling capacity at the Tri-City Plant, which will benefit both Clackamas County Service District No.1 and the Tri-City Service District.

EXECUTIVE SUMMARY:

WES and PGA continue to work together to communicate with stakeholders about a plan to increase solids handling capacity through a shared investment by the two districts at the Tri-City Plant to protect public health and the environment.

Both districts' solids handling processes have exceeded their design capacity and are at a high risk of failure. Approximately four years or more are needed to design and build additional capacity. If the current solids handling system fails, risks include threats to public health and the environment, excessive spending of ratepayer dollars due to solids hauling, and violations of the Tri-City Plant's Clean Water Act Permit.

A recent scientific survey revealed that 94% of WES customers are very satisfied with their sewer service and support upgrading infrastructure to maintain a high quality of service, although only 14% of customers could identify WES as their service provider.

This communications plan seeks to raise awareness of WES and the valuable services it provides while also educating stakeholders about the urgent capacity shortage issue and ongoing district governance discussions. This communications plan is designed to be inclusive and transparent.
