This Voters' Pamphlet contains information designed to assist you in voting. It contains information on three City of Oregon City annexation measures (3-40, 3-41, and 3-42).

No arguments were filed in support of or in opposition to any of the measures.

Please remember, in order to vote on these measures, you must be a registered voter and a resident of Oregon City.

Your voted ballot must be received in the Elections Office, 825 Portland Avenue, Gladstone, OR, by 8:00 PM on election night to be counted. Postmark does not count. If you prefer, instead of mailing your ballot, you may take it to the Oregon City Public Library during its regular hours of operation (see page 7).

If a ballot was delivered to your residence for someone who should no longer be receiving ballots at your address, please write "RETURN" on the envelope and place it back in your mail box. If a ballot was sent to someone who is deceased, please write "DECEASED" on the envelope and place it back in your mailbox.

The address for internet access for election night results is on page 7.

If you need assistance voting your ballot, or if you have any questions about this election, or the elections process, please call the Elections Office at 503-655-8510.

BALLOT TITLE**EXPANDS CITY BOUNDARIES TO INCLUDE ADDITIONAL LAND**

QUESTION: Shall the City's boundaries be expanded to include 14.39 acres of additional land on the City's south side for parks and roads?

SUMMARY: This measure would expand the City's boundaries by approximately 14.39 acres by including within the City property described as follows:

A 13.71-acre of land located on the south side of the City, at the end of Jessie Avenue off of Leland Road, more particularly described as T3S, R2E, Section 7D, Tax Lot 501, Willamette Meridian, Clackamas County, Oregon and a 0.68-acre area of land consisting of Haven Road south of Leland Road, more particularly described as a portion of the John S. Howland D.L.C., No. 45, within Section 7, T3S, R2E, Willamette Meridian, Clackamas County, Oregon.

One portion is proposed for annexation to facilitate master planning and future development as a park. The other portion is street right-of-way for Haven Road. Both properties meet all requirements for annexation into the City and services can be provided to the properties. Both properties are zoned FU-10 (future urbanizable with a 10-acre minimum lot size) and are within the City's urban growth boundaries.

EXPLANATORY STATEMENT

This measure would approve expansion of the City limits of the City of Oregon City by 14.39 acres.

PROPERTY LOCATION:

Both properties are located on the south side of the City for parks and roads at the end of Jessie Avenue off of Leland Road, more particularly: Tax Lot 501, SE1/4 of Section 7, T3S, R2E, W.M., Clackamas County, Oregon.

PROPERTY DESCRIPTION:

The applicant (City of Oregon City) proposes annexation to the City to facilitate master planning for a park. The parcel size is 13.71 acres. There is a second parcel consisting of 0.68 acre of land consisting of Haven Road south of Leland Road, more particularly described as a portion of the John S. Howland D.L.C., No. 45, within Section 7, T3S, R2E, Willamette Meridian, Clackamas County for street right-of-way for Haven Road.

SERVICE AVAILABILITY:

Upon approval of annexation, the City shall transfer the fire and police services from Clackamas County Rural Fire Protection District #1 and Clackamas County Sheriff's Department to Tualatin Valley Fire & Rescue - East Division of Oregon City and Oregon City Police Department.

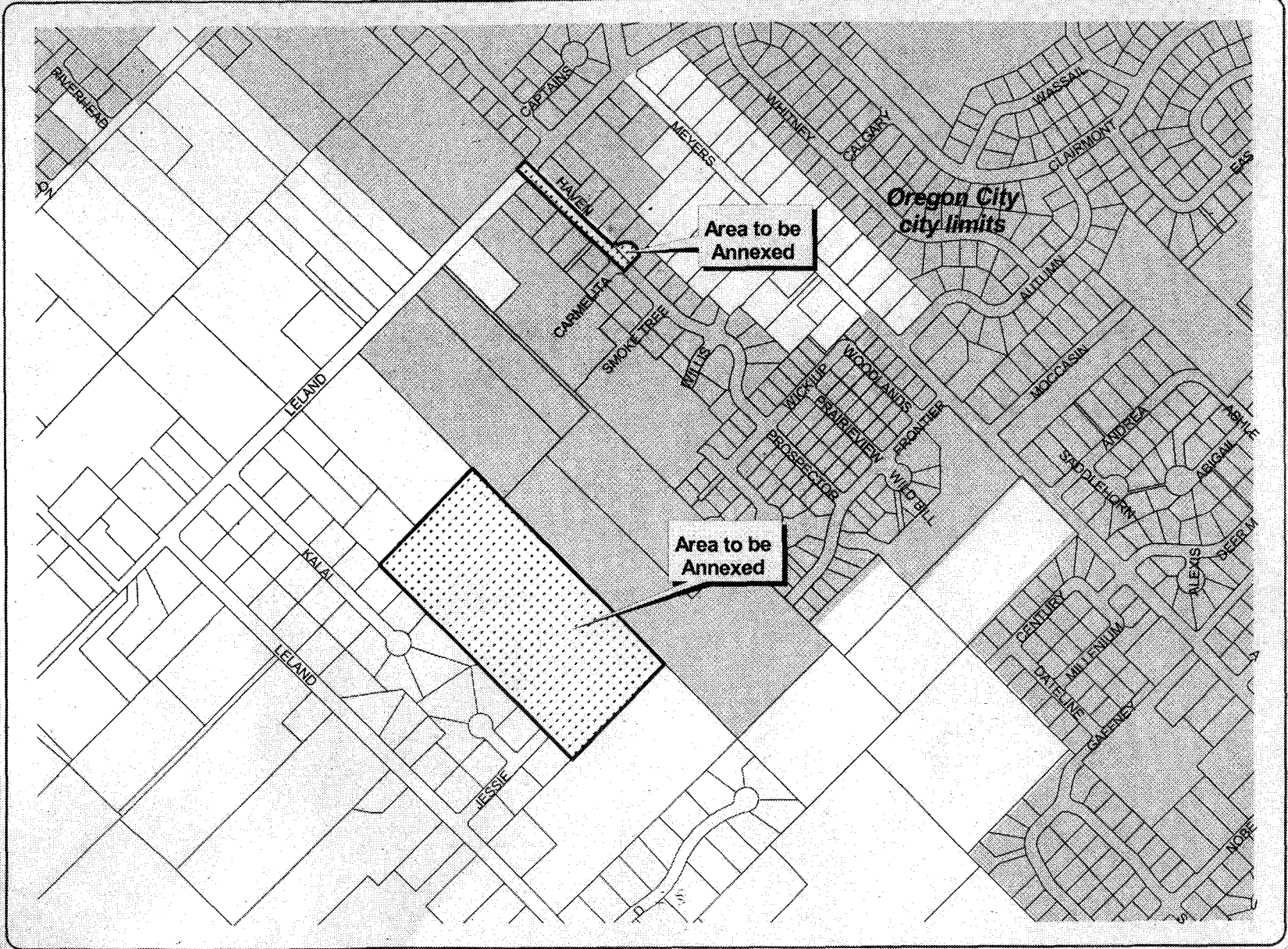
The City Commission of Oregon City conducted a public hearing and approved this request by unanimous vote and set the date of election for September 18, 2001.

Measure No. 3-41**DID YOU KNOW?**

- Q: What if I do not receive a ballot?**
A: If you do not receive a ballot within a week after they have been mailed, call the elections office. Your registration will be checked and if found to be current, a replacement ballot will be mailed to you.
- Q: What if I need assistance in voting?**
A: Call the elections office for further instructions.
- Q: What if I make a mistake on my ballot?**
A: Call the elections office for further instructions.
- Q: If I forget to place my computer ballot card into the secrecy envelope, will my ballot still be counted?**
A: Yes, your ballot will still be counted.
- Q: What if I change my mind after I have returned my ballot?**
A: As soon as you deposit your ballot in the mailbox or at a drop site location, your ballot is considered cast. A new ballot cannot be issued on which to re-vote.
- Q: Does my ballot have to be returned by mail?**
A: You may return your ballot by mail or drop it off at any designated drop site location in the state. The locations and hours of operation of Clackamas County drop sites are listed on page 7 of this pamphlet.
- Q: When must my voted ballot be returned?**
A: Your voted ballot must be received in any county election office or designated drop site location by 8:00 p.m. election night. *Postmark does not count!* Office hours on election day are 7:00 a.m. to 8:00 p.m.

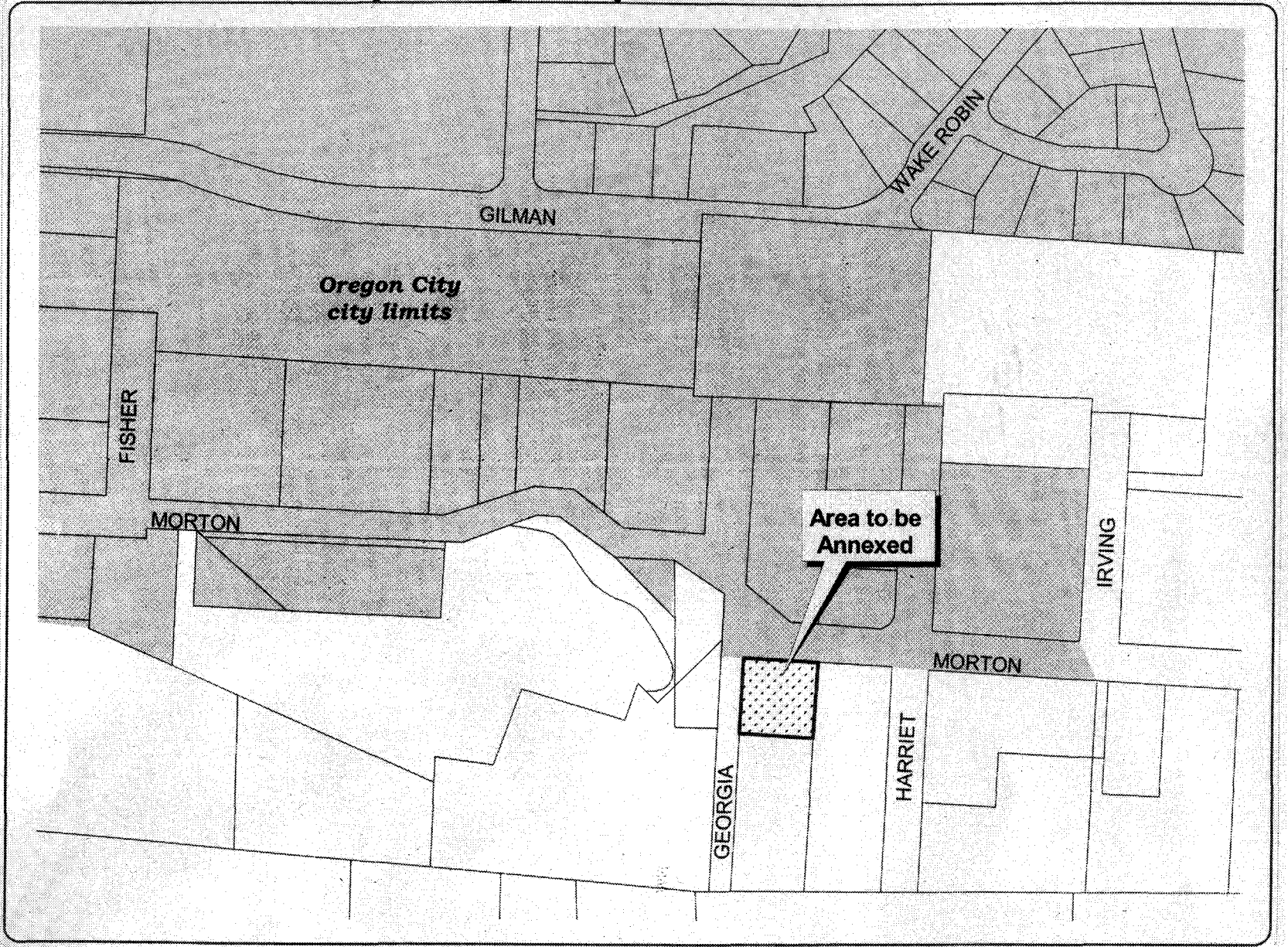
