Proclamation to declare September 26th 2011 As Family Day- A Day to Eat Dinner with Your Children in Clackamas County

Family Day - A Day to Eat Dinner with Your Children was launched in 2001 by the National Center on Addiction and Substance Abuse at Columbia University. Family Day is a national movement that informs parents that the engagement fostered during frequent family dinners is an effective tool to help keep America's kids substance free. Dinner Makes a Difference!

An extensive body of research conducted for over ten years by The National Center on Addiction and Substance Abuse at Columbia University has shown that frequent family dinners are an effective method in preventing youth substance abuse. Powerful outcomes have been associated with frequency of family dinners. Research shows that when compared to teens who eat dinner with family five or more times per week, teens who have fewer than three family dinners per week are:

- More than twice as likely to have used marijuana in the past 30 days
- Nearly twice as likely to have drunk alcohol or used tobacco in the past 30 days
- More than one and a half times likelier to have gotten drunk in the past 30 days

We know that the most frequently abused substance among our nation's youth is alcohol. Clackamas County youth rates of alcohol and drug use mirror that of the nation. Our most recent data indicates that 21% of eighth graders and 38% of 11th graders report using alcohol at least once in the past 30 days. Physical and social consequences of alcohol abuse among our youth are serious and range from alcohol poisoning, drunk driving, risky sexual behavior, physical aggression, sexual assault, and suicide.

There are also concerning rates of marijuana use among our county's youth. Eleven percent of 8th graders and 24% of 11th graders report they have used marijuana in the last 30 days.

The benefits for family dinners can begin as early as the toddler years. Toddlers learn an array of skills by eating dinner with their families. They learn that they are an important part of their families, by sitting with everyone else. Toddlers who eat dinner at the table with their families have better language development than toddlers who don't. Important social skills such as table manners, utensil use, listening skills, please and thank you, opinion sharing, discussions, helping to prepare food, helping in cleaning the kitchen as well as invaluable focused time with their parents, area all benefits of family dinners!

Clackamas County Commission on Children & Families, through the Children, Youth and Families Division is actively supporting and developing evidenced based programs and initiatives that work

towards preventing youth drug and alcohol use, promoting family togetherness and beginning family dinners early. Some of the programs and initiatives underway in our County include:

- The Clackamas County Prevention Coalition meets monthly to develop and implement effective strategies to reduce youth drug and alcohol use.
- Supporting the development of community drug and alcohol prevention coalitions including the Gladstone Youth Coalition, Drug Free Estacada Families & Youth, Coalition, Oregon City Together, Sandy Community Partners, Vibrant Futures of Milwaukie and Molalla Weed & Seed.
- Above the Influence, (Youth Photovoice), Project using youth photography across Clackamas County to incorporate teen perspectives into prevention planning.
- PreventNet schools is a collaboration between the Commission, local schools and non-profits providing prevention programming for youth at the school site based on the Extended Services Schools Initiative.
- Project Alert, an evidenced-based drug and alcohol prevention program for youth in participating Clackamas County schools.
- The Healthy Start/Healthy Families home visitors discuss the importance of family dinners with new parents while their children are toddlers.
- Strategic Prevention Framework initiative addresses binge drinking in 18-25 years olds.

PROCLAMATION TO PROCLAIM THE 26th OF SEPTEMBER 2011 AS FAMILY DAY – A DAY TO EAT DINNER WITH YOUR CHILDREN FOR CLACKAMAS COUNTY

WHEREAS More than ten years of research conducted by The National Center on Addiction and Substance Abuse (CASA) at Columbia University have consistently found that the more often children and teenagers eat dinner with their families the less likely they are to smoke, drink and use illegal drugs;

WHEREAS teenagers who eat dinner with their families two times a week or less are three and a half times as likely to have used prescription drugs, illegal drugs and three times more likely to have used marijuana;

WHEREAS teenagers who eat dinner with their families are half as likely to smoke cigarettes, smoke marijuana and drink alcohol;

WHEREAS the correlation between family dinners and reduced risk for teen substance abuse are well documented:

WHEREAS parental engagement is known to be one of the most crucial factors in determining the likelihood of substance abuse by teenagers;

WHEREAS kids are particularly vulnerable to substance use during transitions from elementary to middle school, middle to high school, and from high school to college;

WHERAS toddlers benefit from family dinners by learning an array of skills such as table manners, family dynamics, social skills, language development and an open mind to trying new and healthy foods.

WHEREAS toddlers and young children gain self esteem, learning that they are an important part of their family, sitting at the table with everyone else.

WHEREAS family dinners have long constituted a substantial pillar of family life in America:

Approval of Amendment #2 to the Contract with Scott Edwards Architecture LLP For Architectural and Engineering Services in the Development of the Happy Valley Library

The County Library obtained use of the Sunnyside Village Community Center located at 13793 SE Sieben Parkway from the North Clackamas School District and the County to remodel and expand for library purposes. The building originally was a joint project between the County and the North Clackamas School District that began in 1997, with the building completed in 1999.

The Clackamas County Library entered into a contract with Scott Edwards Architecture LLP for architecture and engineering services to remodel and expand the Sunnyside Village Community Center for the purpose of a public library.

Remodeling a building often comes with unexpected challenges including three that have come to light so far: poor soil conditions, changes requested by Water Environment Services (WES) after we opened the bid, and damaged siding and roofing.

During the excavation for the new foundation a layer of brush was found covered by about seven feet of fill dirt. This unexpected discovery required additional excavation, iron, cement, and pier pad work, drainage, and rock. There were also additional expenses resulting from changes by WES.

Demolition revealed moisture damage to the exterior stucco walls. Professional Roof Consultants Inc. was hired to evaluate the extent of the damage and found that the siding on the entire building was installed improperly and the whole building is compromised. The windows were also installed improperly. The building needs all current siding removed, plywood replaced and any mold treated. The windows will also need to be removed and new flashing and waterproofing installed. New energy standards require a higher standard of insulation, vapor barrier and water barrier.

These unexpected changes to the project resulted in a need for additional architectural and engineering services in the amount of \$59,750.00.

The revenue to fund the amendment to the Scott Edwards Architecture LLP contract will come from expense line 212 5530 485180 00004. The revenue is realized from reductions and savings in furniture expenses, along with contingency dollars set aside for this project.

RECOMMENDATION:

Business and Community Services staff respectfully request that the Board approve and execute the above-mentioned amendment to the contract with Scott Edwards Architecture LLP for the Sunnyside Village Public Library Project.

APPROVING A SECOND AMENDMENT TO THE OWNER PARTICIPANT AND DEVELOPMENT AGREEMENT (OPDA) FOR THE MOUNT HOOD CULTURAL CENTER AND MUSEUM UNDER THE GOVERNMENT CAMP VILLAGE REVITALIZATION PLAN

The Development Agency partnered with Clackamas County Community Development and The Mount Hood Cultural Center and Museum (MHCC&M) to construct an elevator in the Museum building, providing full access for people with disabilities. This was necessary to accommodate the needs of visitors as well as allow the Museum to be competitive in its fundraising; full access is a requirement for many grants.

After completion of the project, the MHCC&M contacted the Development Agency and requested relief from \$42,329.80 owing on its contract with Community Development, citing the depressed economy as limiting cash flow and fundraising abilities.

After reviewing a number of alternatives, we have come to an agreement with the Museum whereby the full amount of the outstanding balance will be recovered by Community Development. Half that amount will come from the Development Agency and half will be paid by the Museum in monthly payments over a five year period. The Development Agency will add its half to the long term debt owed to the Agency by the Museum, as shown in the attached amendment to their Owner Participation and Development Agreement.

This arrangement provides flexibility to the MHCC&M and holds it accountable for a payment obligation it can reasonably accommodate.
