SB 99

See e-mail attachments. The Bill of Rights addendum must be reviewed and signed by residents/guardians and posted in your home by October 27th. Trainings need to be completed before January 1, 2025. Starting next week, failure to have the addendum posted or signed copies in client binders could result in citation. The approved training for SB99: **Providing Inclusive Care: Training for Oregon Long-Term Care Facility Staff**, is through [Oregon Care Partners](#) (OCP). The course is free and counts towards your 12 hours of annual training. OCP is a delegated organization, DD courses taken with them are approved trainings.

Weatherizing your home

As temperatures begin to cool, this is a great time to assess the outside of your home. Rain and snow can be hazardous. Check for slimy (algae) spots, especially near gutter downspouts. Consider power washing, using a mild detergent or product designed to prevent buildup of moss and mold. Be sure to keep walkways clear, consider traction strips and make sure you have de-icer on hand.

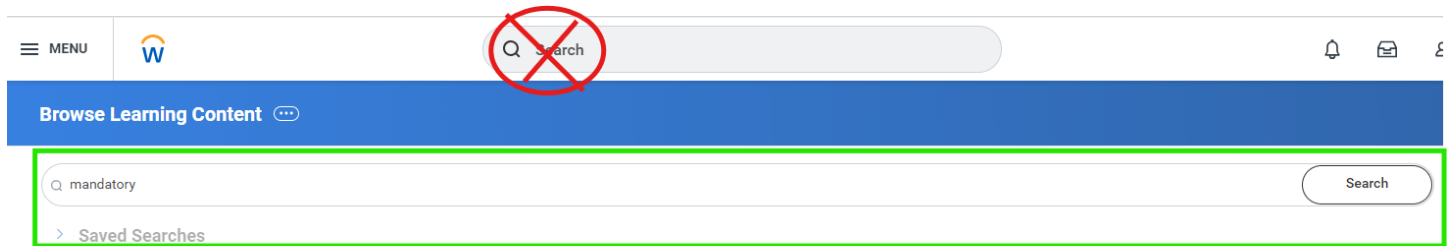

Many of you have reported challenges getting into and locating the Mandatory Abuse Report training course. Be sure to note that your username is generally not your e-mail. Once in, you will see there are 2 search bars, use the bottom one. You can search the word Mandatory and select the ODDS box on your left, that should narrow your options to 3 classes.



AFH testing

To schedule testing, AFH providers will need to contact Libby Struthers via e-mail at lstruthers@clackamas.us. Your email must include the test taker's full NAME, EMAIL ADDRESS, and what test(s) are needed (full tests for new takers, or retaking specific tests). Current photo ID's are required on site. All tests are from 10am-12pm in DSB Room 119 located at 150 Beaver Creek Rd, Oregon City, OR 97045. Arrive at least 15 minutes early. Anyone arriving late will not be admitted and will need to reschedule.

DRC UPDATE

Currently we have 200+ vacancies in Clackamas County and 800+ in the state. Per rule you are required to notify our DRCs if you are interested in a referral from a brokerage or another county, before admitting them to your home. Support documents must be completed prior to move in.
