  - a. Project Turnkey Fill in huge gap for Medium/Transitional Shelters; from street/shelter into voucher/permanent housing. 45-90 day stays. Not night to night shelter. All services offered. Partnering with Sheriff's – they are very involved with this.
    - i. Funds through the State of Oregon, to purchase by and large hotels. Pairing those funds: received allocation earnings on Metro bonds, around \$4MM, Metro oversight committee wants it to go to Rapid PSH.
