STATEMENT OF RIGHTS

- 1. Prior to the Hearing. You have the right to make the following requests:
 - (A) You can request the opportunity to review public records and to talk to County staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
 - (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
 - (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. Procedure. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence, the burden is on the County to establish by a preponderance of the evidence that a violation exists, or existed. Either party may, at their own expense, obtain an attorney to represent them at the hearing. If you wish to be represented by an attorney they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question the parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. Record of Proceedings. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. Hearings Officer. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence, and interpret and apply the law. After the hearing is closed the Hearings Officer will enter written findings of fact, conclusions of law, and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a Final Order or Continuing Order. The Hearings Officers Order is the final decision of the County, and may be appealed pursuant to Oregon law. - 5. Right to Recess. If, during the course of the hearing, Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceeding be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- 6. <u>Right to Appeal</u>. The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearings Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, appellant is responsible for all costs of appeal including preparation of transcript.

COMPLAINT AND REQUEST FOR HEARING

I, Jennifer Kauppi, Code Enforcement Specialist for Clackamas County, allege the following:

1.

Respondent's mailing address is: 3620 SW Borland Rd., Tualatin, OR 97062.

2.

The Respondent(s) own/owns or occupies the address or location of the violation(s) of law alleged in this Complaint is 58998 E Chalet Place, Sandy, OR 97055 also known as T2S, R6E, Section 22BD, Tax Lot 01800, and is located in Clackamas County, Oregon. The property is zoned RRFF5 and is the location of violation(s) asserted by the County.

3.

On or about the 26TH day of November, 2024, the 22nd day of January, 2025, and on the 13th day of February, 2025 the Respondents violated the following law, in the following way:

Page 1 of 3 – COMPLAINT AND REQUEST FOR HEARING File No. $\,$ V0047424

a. Respondents violated the Clackamas County Building Code, Chapter 9.02.040 by failing to obtain approved permits and approved final inspections for a patio cover and electrical for a hot tub connection. This violation is a Priority 1 violation pursuant to the Clackamas County Violation Priorities.

4.

The Department initiating this procedure is the Code Enforcement Section of the Department of Transportation and Development.

5.

Notice of the violation was given to Respondents in the following manner: Violation Notices dated November 26, 2024 and January 22, 2025 and Citation and Complaint 2400474-1 was mailed via first class mail on February 13, 2025. A copy of the notice document is attached to this Complaint as Exhibits C, E and F and incorporated by this reference.

6.

Based on these allegations, petitioner requests that a hearing be set in this matter.

Petitioner seeks an Order from the Hearings Officer granting the following relief:

- 1. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondents to immediately abate the violation and bring the property at issue into compliance with all laws, and permanently enjoining Respondents from violating these laws in the future;
- 2. Pursuant to Clackamas County Code Section 2.07.090, imposing a civil penalty against Respondents for each violation, within the range established by the Board of County Commissioners. Said range for a Building Code Priority 1 violation being \$750.00 to \$1,000.00 per occurrence as provided by Appendix B to the Clackamas County Code;

History of Events and Exhibits:

November 12, 2024 Exhibit A I conducted a site inspection of the subject property in order to provide County Counsel with updated photos of the property for an unabated building code violation for an addition to the single-family residence without approved permits file number V0025816. During this inspection, I observed a new patio cover and hot tub that had not been present during a previous inspection of the property.


November 18, 2024 Exhibit B Correspondence was sent to Debra Crawford regarding the patio cover and electrical for the hot tub. I requested the Respondent contact me within ten days of the date of the letter. I did not receive communication from the Respondent.

November 26, 2024 Exhibit C Correspondence was sent to Debra Crawford providing her with a deadline date of December 30 2024 to abate the violation. This correspondence was not returned to the County.

December 31, 2024 Exhibit D I reviewed the County records and found no building or electrical permits had been submitted to the County for the patio cover or electrical for the hot tub. Citation 2400474 was issued for the Priority 1 Building Code violation. There is no fine amount for this citation as the County is seeking civil penalties in this matter. The citation was not returned to the County and was not paid.

January 22, 2025 Exhibit E I was preparing this file for a hearing when I found that the ownership of the property had been updated with the tax assessor office on December 20, 2024. This update added Aaron Randels as an owner of the property. Citation 2400474 was voided, and an Update Notice of Violation was mailed to the Respondents providing a deadline date of February 6, 2025 to abate the violation.


February 13, 2025 Exhibit F I reviewed the County records and found no building or electrical permits had been submitted to the County. Citation 2400474-1 was issued for the Priority 1 Building Code violation. There is no fine amount for this citation as the County is seeking civil penalties in this matter.



After a review of County records revealed that permits for the building and electrical work had not been submitted to the Clackamas County Building Department, this matter was referred to the Hearings Officer.

If the Compliance Hearings Officer affirms the County's position that a violation of the Building Code, Title 9.02.040 exists, the County is requesting a Final Order in this matter recommending the following:

- The imposition of civil penalties for the Building Code violation of up to \$1,000.00 for date cited February 13, 2025.
- The administrative compliance fee to be imposed from November 2024 until the violation is abated. As of this report the total is \$225.00
- The County requests the Hearings Officer to permanently prohibit the Respondents from violating this law in the future.
- The County is requesting the Hearings Officer to authorize the County further enforcement action including to proceed to Circuit Court.

This letter serves as notice of a violation of the Clackamas County Code. The violations include:

Patio cover over 200 square feet without approved permits

Electrical installed for hot tub connection

VIOLATIONS & HOW TO RESOLVE

On November 12, 2024, I conducted a follow up inspection for the above referenced property for the unabated Building Code violation from 2023. During that inspection I found that a new patio cover over 200 square feet in size and a hot tub at the front of the property.

I reviewed County records and found no approved permits for the patio cover or the electrical for the installation of the hot tub.

The construction of this patio cover and electrical without approved permits constitutes a violation of Clackamas County Code, Title 9.02.040 (D)(E). In order to abate the violation(s), you must complete the following **no later than December 30, 2024:**

Patio Cover

- Please submit, or have your professional submit, the building permit application(s), technically complete plans and appropriate fee(s). Permits are accepted online only, for more information on this process please refer to the County's website at https://www.clackamas.us/building
 - All requests for additional information in order to complete plan review must be responded to within 10 days of being notified.
 - The permit must be picked up within ten days of being
 - Please schedule all inspections so that final inspections may be obtained not later than 45 days of the date of receipt of your approved permit(s).

Hot tub electrical connection

- Please submit or have your professional submit the electrical permit application for the hot tub connection.
 - All requests for additional information in order to process the application must be responded to within 10 days of being notified.
 - o The permit must be picked up within ten days of being notified.
 - Please schedule all inspections so that final inspections may be obtained not later than 45 days of the date of receipt of your approved permit(s).

Important Notices

- Administrative Compliance Fees. It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. An administration compliance fee of \$75 will now be assessed monthly until the violations are abated.
- 2. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, and (2) referral of this matter to the County Code Enforcement Compliance Hearings Officer.
- 3. Request for a Hearing: If you dispute the existence of the violations described in the enclosed letter you may request a hearing before the Hearings Officer by sending a written request for a hearing, including your name and address to: Code Enforcement Section, 150 Beavercreek Rd., Oregon City, OR 97045, or at codeenforcement@clackamas.us.
- 4. **Potential Fines and Penalties:** The Clackamas County Code provides for Citation fine amounts of up to \$500 and additional civil penalties imposed by the Hearings Officer of up to \$3,500 for each day the County verifies the noncompliance. Fine amounts and civil penalties may be assessed for each cited violation and may be assessed separately against each named party. In addition, the Hearings Officer may order the violation to be abated by the County at the expense of the property owner(s) and responsible parties.
- 5. **Voluntary Compliance:** Clackamas County encourages voluntary compliance with code violations to support a safe and healthy community for all. Please note that when a property owner works cooperatively with the County to resolve a confirmed code enforcement violation, the County may in its discretion waive all or part of the \$75 per month administrative fee.
- 6. Non-Compliance may result in a lien upon your property: Fines and costs are payable upon the effective date of the final order declaring the fine and costs. Fines and costs under this Chapter are a debt owing to the County, pursuant to ORS 30.460, and may be collected in the same manner as any other debt allowed by law. If fines or costs are not paid within 60 days after payment is ordered, the County may file and record the order for payment in the County Clerk Lien Record.
- 7. **Final Order may be enforced in Circuit Court:** Also, be advised that non-compliance with a Hearings Officer's Order may result in the matter being referred to County Counsel for legal action in Circuit Court which may result in additional penalties or other sanctions.
- 8. **Recurrences will result in additional Citations:** Finally, recurrences of abated violations may result in the issuance of a citation without prior notice.

VIOLATIONS & HOW TO RESOLVE

On November 12, 2024, I conducted a follow up inspection for the above referenced property for the unabated Building Code violation from 2023. During that inspection I found that a new patio cover over 200 square feet in size and a hot tub at the front of the property.

I reviewed County records and found no approved permits for the patio cover or the electrical for the installation of the hot tub.

The construction of this patio cover and electrical without approved permits constitutes a violation of Clackamas County Code, Title 9.02.040 (D)(E). In order to abate the violation(s), you must complete the following **no later than February 6, 2025:**



Important Notices

- Administrative Compliance Fees. It is important that you contact the Code Enforcement Section to resolve the violations described in the enclosed letter. An administration compliance fee of \$75 will now be assessed monthly until the violations are abated.
- 2. Failure to resolve those violations may result in one or more of the following: (1) a citation and fine, and (2) referral of this matter to the County Code Enforcement Compliance Hearings Officer.
- 3. Request for a Hearing: If you dispute the existence of the violations described in the enclosed letter you may request a hearing before the Hearings Officer by sending a written request for a hearing, including your name and address to: Code Enforcement Section, 150 Beavercreek Rd., Oregon City, OR 97045, or at codeenforcement@clackamas.us.
