RE: Economic Development and Clackamas County Business Alliance Dues
DATE: January 12, 2022

This is an update of all economic development organizations Clackamas County pays annual dues to, and the total dues the county has paid to Clackamas County Business Alliance to date.

## Economic Development Organization 2022 Dues - Total: \$62,131.50

Dues within this category support annual memberships for participation with 27 economic development organizations including 10 local chambers of commerce. These dues are primarily funded through State Lottery dollars with the chambers of commerce dues supported through the County General Fund.

Clackamas County Business Alliance Dues 2006-2020 Dues - Total: \$505,000.00
CCBA describes their organization as "a non-profit association of business and community members that are committed to the economic strength of Clackamas County. CCBA directly affects policy making by leveraging the strengths of the public and private sectors to ensure the economic vitality of Clackamas County."

Membership for the county includes invitations to monthly breakfast forums, quarterly board meetings, discounts on special events, e-newsletters, opportunities to serve on Board and committees, and invitations to informational meetings and receptions with elected officials at the local, state and federal levels.

To date, since 2006, Clackamas County has paid CCBA \$505,000. Dues for the county are outstanding as of July 1, 2021. On December 14, 2021 the Board of County Commissioners approved a $\$ 5,000$ advance payment. The BCC agreed to consider the remaining $\$ 5,000$ based on CCBA's existing fee structure after the winter Recess when the full Board could have an opportunity to discuss and consider.

In reviewing payments made to CCBA, staff recognize an inconsistent fee structure and payments made over the years. Currently, fees due from the County are based on a maximum dollar amount of $\$ 10,000$ per year for cities or counties, or otherwise calculated at $\$ 0.075$ multiplied by population.

In recent years, notably 2018 - 2020, Clackamas County received and paid invoices from CCBA totaling $\$ 225,000-\$ 75,000$ for 2018, $\$ 100,000$ for 2019 and $\$ 50,000$ through July 2020. The $\$ 200,000$ in 2018-2020 was approved by the Board. The increase in these costs using lottery funds in addition to the $\$ 25,000$ annual dues were associated with an Agreement of Support for CCBA to develop membership, build capacity and to emphasize business development and assistance on legislative issues for Clackamas County, the Sunrise Corridor project and employment lands.

The Board recently requested an overview of commissioner involvement in interviews for Appointed Boards and Commissions.

In 2019, commissioners adopted protocols (attached) for participating in the interview process for applicants for three of the County's ABCs:

- Budget Committee
- Fair Board
- Planning Commission

Recently, commissioners participated in the interview process for an additional three ABCs:

- Audit Committee
- Internal Audit Oversight Committee
- Emergency Preparedness Council

Participating in the interview process can be time consuming for the applicants, staff and commissioners, and scheduling around the Board's schedules can prove challenging. Staff recommends that the Board engage in membership selection only on the committees that they interact with the most and that provide the most frequent advice and recommendations.

Does the Board wish to modify or expand the list of ABCs for which a Commissioner(s) shall participate in the interview for vacant positions?

## ABC Appointment Protocols

Adopted by BCC 02-19-19
Historically, the Board has shown interest in interviewing applicants for three committees: Budget Committee, Planning Commission, and Fair Board. In order to avoid confusion on the part of staff and the Board, this protocol paper outlines the process the Commissioners have agreed to follow when openings on these committees occur.

## Budget Committee

Upon closure of the recruitment, two or more Commissioners will interview all new qualified candidates, with the option of interviewing applicants seeking reappointment. Budget staff may be included in the interview process if interested. Upon completion of the interviews, the Board will discuss their findings during an open session and make their appointment(s).

## Planning Commission

The BCC will be asked to appoint two BCC representatives to participate in interviews with department staff and planning commission members. Once interviews have occurred, a recommendation will be made to the BCC. If there is not consensus among the board, additional interviews may be held by the remaining Board members prior to an appointment being made.

## Fair Board

The BCC will be asked to appoint two BCC representatives to participate in interviews with two fair board members, and one additional external person. Once interviews have occurred, a recommendation will be made to the BCC. If there is not consensus among the board, additional interviews may be held by the remaining Board members prior to an appointment being made.
*The appointed representatives from the board for each of these committees will only serve that year. When the recruitment opens again, the board will have the opportunity to keep the same representatives or choose new ones.
*In order to provide for ample scheduling time, staff liaisons are encouraged to seek the BCC representatives at the time the recruitment opens. Failure to do so may create delays in the scheduling of interviews and may lead to positions not being filled in a timely manner following the closure of the recruitment.
