In 2022 the Board discussed the protocols for participating in the interview process for specific County Advisory Boards and Commissions (ABCs). The Board expanded the number of ABCs they are interested in, to include the following:

- Audit Committee
- Emergency Preparedness Council

In order to address scheduling challenges and the time commitment needed to participate in the interview process for applicants to the ABCs listed above, staff recommends each Commissioner participates in the committees they attend or are interested in the most.
