In accordance with Local Contract Review Board Rule C-047-740 and above referenced Program Offer, the Housing Authority of Clackamas County ("Authority") intends to award a contract to the above named apparent successful proposers. The above named apparent successful proposers shall not acquire any legal or equitable rights relative to the contract services until a contract containing terms and conditions acceptable to the Authority is executed. Successful proposals may be funded completely, partially, or not funded dependent on contract negotiations. The Authority intends to begin contract negotiations immediately following the seven (7) day protest period and successful proposers should be prepared to attend any required meetings. If any apparent successful proposers fail to negotiate and execute a contract with the Authority, the Authority may revoke the award and award the contract to the next highest ranked proposer or withdraw the Program Offer.

This Notice of Intent to Award Contracts starts the seven (7) calendar day period in which an unsuccessful proposer may file a protest in accordance with Rule C-047-0740. Unsuccessful proposers may review the procurement file upon appointment. Any protest must be in writing and must be delivered by hand delivery, mail or email to the below address. Protests may not be submitted by fax.
