## INTRODUCTION

This report presents the results of an online survey conducted among resident homeowners in the Surface Water Management Agency of Clackamas County (SWMACC) area. The research was conducted by CFM Strategic Communications, Inc. (CFM) on behalf of Water Environment Services (WES). Research objectives were to assess the priorities for water management issues, priorities for SWMACC performing potential new surface water management services beyond those required by regulation and price sensitivity for paying for new services.

CFM worked with WES to design the research methodology, write the questionnaire and manage the research data collection process.

A total of 222 people accessed the survey between November 8, 2010 and December 6, 2010. Of those, 162 passed screening questions designed to ensure individuals were residents and homeowners in the SWMACC area. Potential respondents came from two sources. The Stafford Hamlet provided a list of 286 email addresses. Of those, 71 accessed the survey and 55 passed screening questions. The second group was recruited by a direct mail piece sent to more than 2,000 ratepayer households in the SWMACC area. A total of 151 persons responded to the direct mail piece and 109 passed the screener.

# SUMMARY

### Expanding Surface Water Services

Almost all ratepayers (90%+) in the SWMACC area are aware households pay fees to the district to manage surface water in the area. Of those aware, two in three know the rate is \$24 every six months.

Among those surface water services required by regulation, at least two in three ratepayers rate as high priorities active water resource management efforts, such as infrastructure maintenance, stream side restoration, prevention, monitoring and flood control.

More than half rate as higher priorities three proposed new services – improving under-performing infrastructure, public education and partnerships to improve habitat.

Overall, 60% say they are willing to pay \$1 more per month to fund additional surface water programs. However, opinions varied by email source. Those from the Stafford Hamlet list (72%) were willing to pay more than those recruited from the community (50%). These results suggest that a majority of ratepayers support increasing fees to expand surface water management beyond those services required by regulation.

#### General Topics

The economy and residential growth are the most important issues facing the SWMACC area.

More than 80% of the ratepayers are very/somewhat interested in issues related to the Tualatin River and local streams.

Both SWMACC (79%) and WES (89%) are well known in the community.

About a third of the community has volunteered to work on a local environmental effort. More than half say they are willing to volunteer on future local environmental programs.

- Adequate and clean drinking water (33%).

Opinions about problems varied slightly by source of recruitment. The economy

was the most important problem among those from the general population list,



while those from the Hamlet list were equally concerned about the economy and water management issues.

More than eight in ten of all groups said they were very or somewhat interested in issue related to the Tualatin River and local streams.

disposal of pollutants and partnerships to improve aquatic habitat and biological communities. More than four in ten rated partnerships with landowners and watershed councils, wetland, riparian are and in-stream restoration projects and inspections to identify barriers to fish passage as high priorities. Less than four in adding water quality treatment facilities and street cleaning as high priorities.



People from the Hamlet list rated six of seven projects higher priorities than those from the general population.

### Price Sensitivity

When people were asked how much more per month they were willing to pay for one or more of the proposed new services, 32% said they would pay an additional \$5/month, 8% said an additional \$3 per month and 17% said \$1 per month

more. 40% were not willing to pay more. Opinions about additional fees differed significantly by source of respondent. Seven in ten (72%) of those from the Hamlet list were willing to pay at least a \$1 per month more for additional services, compared to half (50%) of those from the general population list.



#### **Community Involvement**

More than three in ten of all groups say they have participated in local environmental projects during the past three years.

Willingness to participate is strong, with more than half saying they would volunteer to help with an environmental project. The Surface Water Management Agency of Clackamas County or SWMACC was created to address water quality regulatory requirements put in place by the Oregon Department of Environmental Quality's (DEQ) to address environmental concerns regarding fertilizer, bacteria, dissolved oxygen and toxics in the Tualatin River Basin. Water Environment Service of Clackamas County, or WES, currently provides District customers with the following water quality management services. These services are required by DEQ in order to meet these regulatory requirements and are paid for through District rates.

- Environmental monitoring
- Development plan review and permitting
- Erosion prevention and sediment control
- Maintenance of existing infrastructure
- Public education and outreach
