OFFICIAL NOTICE: BUSINESS FOOD WASTE REQUIREMENT

This letter is to inform you of a new ordinance that applies to your business and the free support available to help you reach compliance. **By March 31**, **2023**, your business will be required to separate food scraps for compost rather than garbage. This requirement is being phased in over the next two years starting with the largest food scraps producers.

This region-wide requirement will keep food scraps out of the landfill and put it to better use as an energy source and nutrient-rich fertilizer for farms, all of which help reduce our climate impact.

What is required?

- 1. Set up and maintain **food scraps collection service.** To get started, do one of the following:
 - Contact your franchised garbage and recycling service provider (<u>www.oregonmetro.gov/hauler</u>)
 - Contact a Clackamas County recycling specialist (contact info below)





In most urban communities in Clackamas County, there is no additional cost for food only service. It is already included in your cost of garbage service.

- 2. Set up and maintain **internal bins with clear labels** (<u>free signage and stickers are available</u>).
- 3. Put all food scraps* in the compost bin instead of into the garbage.

*This requirement does not apply to waste disposed of by the public or customers. It only applies to food scraps handled by employees.

Free support and tools

Clackamas County's Sustainability & Solid Waste program has been designated by the cities of Gladstone, Happy Valley, Lake Oswego, Oregon City, Milwaukie, West Linn, and Wilsonville to provide notification, free materials, support and education to assist businesses with this new requirement.

Do not wait until the last minute – you will need time to set up and train staff, and our team will respond on a first-come, first-serve basis.

Property managers must allow you to set up food scraps collection service. If your property manager provides garbage service, they are required to also provide food scraps service, if requested.
