#### STATEMENT OF RIGHTS

1. Prior to the Hearing. You have the right to make the following requests:

- (A) You can request the opportunity to review public records and to talk to County staff about the violations or request a subpoena for that purpose if the County does not allow you to do so.
- (B) You can request that the Hearings Officer postpone the hearing for good cause by writing the Hearings Officer at least 7 calendar days prior to the scheduled hearing date.
- (C) You can request that the Hearings Officer decide the matter based exclusively on written materials from the parties or conduct the hearing by phone.
- 2. <u>Procedure</u>. The hearing will be governed by general rules of procedure designed to allow you to hear and confront the evidence against you, and for you to present evidence favorable to you. You are not required to present any evidence, the burden is on the County to establish by a preponderance of the
- evidence that a violation exists, or existed. Either party may, at their own expense, obtain an attorney to represent them at the hearing. If you wish to be represented by an attorney they need only notify the County and the Hearings Officer in writing of their intent to appear on your behalf. The County will present evidence first, and then you may question that evidence. You may then present your own evidence, if you wish, and the County may question your evidence. Testimony by witnesses is evidence. The Hearings Officer may inquire into any facts that are relevant to the hearing and may question the
- parties or witnesses about the case. Evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their serious affairs shall be admissible.
- 3. <u>Record of Proceedings</u>. An audio record will be made of the proceedings when a hearing is conducted. The audio record is available through the Clackamas County Code Enforcement Section and is available to you upon request.
- 4. <u>Hearings Officer</u>. The Hearings Officer is an independent contractor paid by the County to conduct hearings and render decisions. He/she is not a County employee. His/her function is to preside over the hearing, make a record of proceedings, consider admissible evidence, and interpret and apply the law. After the hearing is closed the Hearings Officer will enter written findings of fact, conclusions of law, and any Order deemed proper. If a violation is proven, then the Order may include civil penalties, fines, administrative fees, or may require the respondent to take certain actions, or refrain from certain actions. An Order issued by the Hearings Officer may be a Final Order or Continuing Order. The Hearings Officers Order is the final decision of the County, and may be appealed pursuant to Oregon law. - 5. <u>Right to Recess</u>. If, during the course of the hearing, Respondent or the County requests a recess or postponement, or additional time to present crucial evidence, the Hearings Officer may allow a continuance of the hearing for good cause. The Respondent may also request that the proceeding be continued after the end of the hearing if the Respondent determines that additional evidence should be brought to the attention of the Hearings Officer.
- 6. <u>Right to Appeal</u>. The Final Order of the Hearings Officer shall set forth the right of the respondent to appeal any adverse Order. Appeal may be taken pursuant to Section 2.07.130 of the Clackamas County Hearings Officer Code, and Oregon Revised Statute 34.010-34.100. If appeal is taken, appellant is responsible for all costs of appeal including preparation of transcript.

I, Shane Potter, Code Enforcement Specialist for Clackamas County, allege the following:

1.

Respondents' place of residence is: 8705 SE 307th Ave., Boring, OR 97009

2.

The address or location of the violations of law alleged in this Complaint is:

8705 SE 307th Ave., Boring, OR 97009 also known as T1S, R4E, Section 29B, Tax Lot

01601, and is located in Clackamas County, Oregon.

3.

On or about the 7<sup>th</sup> day of June, 2022, Respondents violated the following laws, in the following ways:

Respondents violated Section 12.316.03 of the Clackamas County Zoning and Development Ordinance (ZDO) by operating a commercial business without land use approval on the above referenced property. Said property is zoned RRFF-5 (Rural Residential Farm Forest 5 Acre) District. This violation is a Priority 2 violation pursuant to the Clackamas County Violation Priorities.

4.

The Department initiating this procedure is the Code Compliance Section of the Department of Transportation and Development.

5.

Notice of the violations was given to Respondents in the following manner: Administrative Citation No. 2200192 - 1 in the amount of \$400.00 was mailed first class mail on August 23, 2022. A copy of the notice document is attached to this Complaint as Exhibit I, and incorporated by this reference.

Based on these allegations, petitioner requests that a hearing be set in this matter. Petitioner seeks an Order from the Hearings Officer granting the following relief:

1. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondents to immediately abate the violation and bring the property at issue into compliance with all laws, and permanently enjoining respondents from violating these laws in the future;

2. Pursuant to Clackamas County Code Section 2.07.090, imposing a civil penalty against Respondents for each violation within the range established by Board of County Commissioners. Said range for a Priority 2 violation being \$500.00 to \$2,500.00 per occurrence as provided by Appendix B to the

#### Clackamas County Code;

3. Pursuant to Clackamas County Code Section 2.07.090, ordering Respondents to pay an administrative compliance fee as provided by Appendix A to the Clackamas County Code; and

4. Ordering any other relief deemed reasonably necessary to correct the violations.

History of Events and Exhibits:

May 2, 2022 Exhibit A	Clackamas County received a complaint alleging a business operating at this location without land use approval.
May 11, 2022 Exhibit B	Correspondence was mailed first class mail to the Respondent.
June 7, 2022 Exhibit C	Research online shows the business registered to this location as Absolute Comfort Heating & Cooling NW Inc.
June 7, 2022 Exhibit D	Facts of the alleged violation were reviewed, the violation verified, and Notice of Violation mailed containing a statement of the facts that support the finding a violation exists on the property. The Notice of Violation was mailed via first class mail. Mail was not returned.
June 13, 2022 Exhibit E	Clackamas County Code Enforcement Specialist (CES) Shane Potter performed a site visit showing company vehicles parked on site. Photos were taken.
July 20, 2022 Exhibit F	CES Potter received an email from Rob Baird who stated they just sent a zoning application in and wanted to know how to pay the fee. CES Potter provided the contact information for the Clackamas County Planning and Zoning Division and explained he would need to submit the application to them along with payment.
August 17, 2022 Exhibit G	CES Potter asked the Clackamas County Planning and Zoning Division if an application had been made since none were seen on our computer system. Melissa Ahrens a Clackamas County

	Planner responded back that there has not been a home occupation application submitted for the property.
August 23, 2022 Exhibit H	CES Potter performed as search on the internet finding the Absolute Comfort Heating and Cooling NW, Inc. website showing the business is located at this address.
August 23, 2022 Exhibit I	Citation #2200192 – 1 for operating a business without land use approval was sent via first class mail. The first class mail was not returned. This citation has not been paid.
September 19, 2022 Exhibit J	After receiving continued complaints CES Potter performed a site visit and did not find any vehicles on site during this site visit. Photos were taken.
March 22, 2023 Exhibit K	A review of the internet shows the business remains registered to this site and the website continues to show this location.
March 28, 2023	The County referred this matter to the Code Enforcement Hearings Officer.

If the Hearings Officer affirms the County's position that a violation of the Zoning Ordinance exists on the subject property, the County would request a Continuing Order be issued requiring the Respondent:

- Vacate the use at this location, or
- Submit the appropriate land use applications within 30 days of the Hearing Officers decision and obtain land use approval to maintain the use on site.
  - If the Planning and Zoning Division determines that the application is incomplete the Respondent will have 30 days to provide a completed application to the Planning and Zoning Division.
  - If land use approval is granted all conditions of approval must be met.

The County will submit a Post Hearing Status Report. The report will be sent to the Compliance Hearings Officer and to the Respondent. The report may include the following recommendations:

- Payment of Citation #2200192 1 for \$400.00.
- Imposition of civil penalties of up to \$2,500.00
- The administration compliance fee to be imposed from July 2022 and continue to accrue until compliance is achieved. As of the date of this report the total administration compliance fee is \$675.00.
- If the violations are not abated the County may request authorization for further enforcement action including to proceed to Circuit Court.
- The County requests the Hearing's Officer to permanently enjoin the Respondent from violating these laws in the future.




