-CCSO COVID-19 Update: CCSO had 6 (off duty contact) positive cases which developed into 9 cases and an additional 11 for 19 deputies total cases. Nearing end of 2 week period and most employees back at work. Upon learning of exposures, CCSO initiated predetermined COVID protocols to include employee quarantine, scaling back in person roll calls and trainings, closing lobby and training center, reminding employees to utilize masks and all available PPE, assigning a COVID officer to the incident(s) and reiterating all OHA workplace guidelines. -Fallen Officer – Line of Duty Death Remembrance -CPO (Community Planning Organizations) Meetings:
