A Mandatory Pre-Bid Conference will be conducted on Tuesday, May 30, 2017 at 10:00 AM. Bidders shall meet with County representatives in the Tri-City Conference Room located at 15941 S. Agnes Ave., Oregon City, OR 97045 for that purpose. Attendance will be documented through a signin sheet prepared by the County representative. Prime bidders who arrive more than ten (10) minutes after the start time of the meeting (as stated in the solicitation and by the County's watch) or after the discussion portion of the meeting (whichever comes first) shall not be permitted to sign in and will not be permitted to submit a bid on the project.

Bids will be opened and publicly read aloud at the above Delivery address after the Bid Closing. Bid results will also be posted to the Clackamas County Procurement Website shortly after the opening.
