

### PROCLAIMING APRIL 1-30, 2010 AS EARTHQUAKE AWARENESS MONTH IN CLACKAMAS COUNTY

It is respectfully requested that the Board of County Commissioners proclaim the month of April 2010 as Earthquake Awareness Month in Clackamas County.

Clackamas County residents and employees are encouraged to use the designation of April as Earthquake Awareness Month to practice personal safety by taking part in a Drop, Cover and Hold On drill at home and at work. April is also a good time to address hazards in the home and workplace that could cause injury or property damage during a damaging earthquake.

With this proclamation Clackamas County recognizes the threat of future earthquakes and recommends the necessary safety practices to reduce potential losses to life and property.

## Proclaiming April as Earthquake Awareness Month in Clackamas County

WHEREAS, Clackamas County suffered considerable damage from a moderate Magnitude 5.3 earthquake event in 1993 known as the Scotts Mills Earthquake; and

WHEREAS, Scientific evidence indicates that the State of Oregon is at risk for much larger and potentially more damaging earthquakes; and

WHEREAS, A Magnitude 8 or greater earthquake associated with the Cascadia Subduction Zone is expected to generate strong ground shaking throughout western Oregon and a destructive tsunami along the coast, and will be similar to the events that occurred in the Indian Ocean in 2004 and in Chile in 2010; and

WHEREAS, Oregon enacted laws in 1995 and 2001 that require schools, state and local agencies, and large private employers to instruct and drill students and employees on emergency procedures such as those related to earthquakes; and

WHEREAS, Seismic strengthening of existing buildings and public education on local tsunami evacuation is strongly encouraged to further reduce loss of life and property damage: and

WHEREAS, Oregon enacted laws in 2001 that require schools and emergency facilities to meet seismic life safety standards, and in 2005 enacted laws that will provide state funds to help mitigate high risk schools and emergency facilities; and

WHEREAS, The Department of Emergency Management will highlight these preparedness and mitigation procedures and provide increased earthquake safety information to employees and the public and tsunami awareness information for Clackamas County visitors to the Oregon Coast.

**NOW, THEREFORE, WE DO HEREBY PROCLAIM** April 2010 as EARTHQUAKE AWARENESS MONTH in Clackamas County. We urge all employees and County residents to join in this observance by practicing Drop, Cover and Hold as the recommended action for personal protection during an earthquake.

Public Health performs ongoing services in Clackamas County, including prenatal and child home visiting programs, the WIC nutrition education and support, and health education to encourage healthy choices and decrease the availability and use of tobacco products. We are currently completing a community assessment and community engagement project called Roadmap to Healthy Communities.

Public Health also focuses on protection of the health of our county residents, through conducting surveillance and investigation of communicable diseases, inspecting and licensing food service and water systems, responding to outbreaks such as the recent H1N1 pandemic, and working with county staff to plan and train for an effective to response to other emergency events.

### Proclamation declaring April as Child Abuse Prevention Month in Clackamas County for 2010

The Children, Youth & Families Division of the Clackamas County Health, Housing & Human Services Department requests the approval of a Proclamation declaring April as Child Abuse Prevention Month. This important month has traditionally been recognized both nationally and locally by the Clackamas County Board of County Commissioners through a Proclamation. Some of the highlights in the proclamation point out the following:

In 2009 the abuse rate was 6.7 per 1,000 children; state wide the rate is 12.5. The 6.7 constitutes 601 children in 2009 that were confirmed as being abused. Child abuse and neglect is preventable, yet each year in the United States, close to one million children are confirmed victims of child maltreatment. Based on data drawn from a variety of sources, the conservative estimated annual cost of child abuse and neglect is \$750 million. It is expected that with increased economic stress and hardship child abuse and neglect will increase.

Since 2002 the Clackamas County Early Childhood Committee, a sub-committee of the Clackamas County Commission on Children and Families, has coordinated events and developed child abuse prevention information that is targeted at supporting parents, teachers, children and youth, and the community. The Proclamation highlights programs that actively supports and develops best practice programs and initiatives that work towards preventing child abuse and those adverse outcomes that occur as a result of child abuse and neglect.

### **Recommendation:**

Staff recommends the Board approve the attached Child Abuse Prevention Month Proclamation.

# PROCLAMATION TO PROCLAIM THE MONTH OF APRIL 2010 AS NATIONAL CHILD ABUSE PREVENTION MONTH FOR CLACKAMAS COUNTY

Whereas, preventing child abuse and neglect is a community problem that depends on involvement among people throughout the community;

Whereas, data indicate a steady level of child abuse and neglect each year. In 2009, there were 12.5 victims per 1000 children with founded incidents of child abuse and neglect in the state of Oregon. For Clackamas County, child abuse remained steady at 6.7 per 1000 children in 2009. Whether suffering neglect, harsh physical punishment, threat of harm, sexual abuse, or psychological trauma, the children who survive carry the scars of their abuse for the rest of their lives

Whereas, research shows, child abuse and neglect not only directly harm children, but also increase the likelihood of criminal behavior, substance abuse, health problems such as heart disease and obesity, and risky behavior such as smoking;

Whereas, we know, child maltreatment occurs when people find themselves in stressful situations, without community resources, and don't know how to cope;

Whereas, the majority of child abuse cases stems from situations and conditions that are preventable in an engaged and supportive community;

Whereas, child abuse and neglect can be reduced by making sure each family has the support they need to raise their children in a healthy environment;

To improve our future, all citizens should become involved in supporting families in raising their children in a safe, nurturing environment;

To this end, effective child abuse prevention programs succeed because of partnerships created among social service agencies, schools, faith communities, civic organizations, law enforcement agencies, and the business community. Successful programs and initiatives in Clackamas County include:

- Clackamas Branch Oregon Child Protective Services
- Healthy Start of Clackamas County which is a home visitation program for first time parents.
- The Children's Center which supports and conducts medical assessments of children who are suspected victims of abuse or neglect.
- The Clackamas County Multi-Disciplinary Team which includes representatives from the Sheriff's Office,
   District Attorney, Victim's Assistance, Oregon Department of Human Services and County agencies.
- Clackamas County Sheriff's Office Child Abuse and Domestic Violence Summit.
- The Family Education and Support Network parent resource web-page.
- The establishment of the Homeless Children's strategic planning and implementation committee.
- Family Stepping Stones Relief Nursery.

NOW, THEREFORE, the Clackamas County Board of County Commissioners do hereby proclaim the month of April, 2010 as:

### Board Order Declaring the Formation of The Hamlet of Molalla Prairie

The Hamlet and Village program was created by the Board of County Commissioners (BCC) in 2006, as the result of a two-year community involvement process called Complete Communities. This program allows unincorporated communities to have closer connections and better communication with the BCC and County departments.

The proposed Hamlet of Molalla Prairie has completed the required organizational steps, and is now ready for formal Board of County Commissioners approval of its Board of Directors and bylaws. The bylaws include details on the hamlet's purpose, activities and boundary.

The bylaws were approved by a vote of 75 yes, 60 no, and one provisional ballot declared invalid, at a Town Hall meeting March 10, 2010. Please find the following documents attached.

- The bylaws of the Hamlet of Molalla Prairie
- Boundary map for the Hamlet of Molalla Prairie. The boundary includes a majority of the Molalla CPO, the eastern half of the dormant South Canby CPO and a crescent in the north portion of the South Clackamas CPO. South Clackamas CPO approved the inclusion of this section of the CPO since it was not withdrawn from the CPO, but is an overlay of that portion.

In June 2009 a group of interested rural Molalla citizens, headed by Chief Petitioner Carine Goldin, contacted Clackamas County Staff Liaison to investigate the process for creation of a hamlet to represent rural Molalla. As of mid-August they decided to pursue hamlet status. A formation committee of eight members was formed to guide the process. Since the initial formation meeting, nine monthly community meetings have been held. All community meetings were advertised in the Molalla Pioneer newspaper, Molalla Prairie hamlet website, Clackamas County website and through flyers posted throughout the community.

Bylaws were drafted, presented, revised and approved at three community meetings. A postcard was mailed to all landowners identified in a database developed by Clackamas County GIS and based on the County Assessor's records. 1510 postcards were mailed. 1000 flyers were distributed to the community in an outreach effort spearheaded by formation committee members. All written material was sent to and published in the Molalla Pioneer. County Liaison assisted the formation committee as needed.

10 community members agreed to run for the Board of Directors. At the March 10 Town Hall, eight people representing a wide cross section of the community were elected. One-half will

serve an initial one year term and one-half will serve two year terms. Officers will be elected by the Board at the first regularly scheduled meeting.

136 people voted in the formation election. 21 provisional ballots were cast and 20 were verified as valid. That makes this the third largest voting population in the 7 formation elections held so far.

The Hamlet of Molalla Prairie has developed a list of projects that include partnerships with the City of Molalla and the Hamlets of Beavercreek and Mulino. They will also participate in the committees that all other Hamlets and Villages serve on as well. They are ready to begin work on agri-tourism farm tours, farmers market, historical documentation of the rural Molalla area, outreach to community members who expressed skepticism about the usefulness of a hamlet and creation of a communication network including website, electronic bulletin board, publicity about the hamlet and how to participate in the hamlet.

#### RECOMMENDATIONS

- 1. The BCC accept the affirmative results of the March 10 Town Hall meeting; ratify the bylaws; and declare the Hamlet of Molalla Prairie formed.
- 2. Assign the County's Hamlet & Village Liaison to continue to support the work of the Hamlet of Molalla Prairie.

- 2. The formation process for the Hamlet of Molalla Prairie has been completed and the hamlet is formed.

### Approval to Apply for a Grant from the Workforce Investment Council for Specialized Work Force Services

Community Solutions for Clackamas County (CSCC), a division of the Health, Housing & Human Services (H3S) requests approval to apply for a grant from the Workforce Investment Council of Clackamas County (WICCO) for specialized work force services. CSCC currently has a WICCO grant as a subcontractor of Clackamas Community College to provide specialized workforce services for our Working for Independence (WFI) program. The WICCO has decided to subcontract with entities directly, to provide workforce services to job seekers with significant barriers to employment and in need of more intensive services. The source of the funding is the federal Workforce Investment Act (WIA).

CSCC will be applying for approximately \$125,000. The grant period begins July 1, 2010 and ends June 30, 2012. The grant may be renewed.

The grant will provide intensive job training, placement and retention services to job seekers who face significant barriers to employment. The WICCO identified barrier populations to be served in their RFP which our proposal addresses: Residents of Public Housing, Community Corrections clients, people with severe and persistent mental illness, Veterans with Post Traumatic Stress Disorder and Traumatic Brain Injury, and clients of the five Clackamas County treatment courts. It also provides for salaries for an allocated job developer, fringes, travel expenses, office space, equipment, printing and direct training and supportive services to job seekers we will be serving in Clackamas County. No County General Funds are involved.

### Recommendation

We recommend approval to apply for this grant. If awarded, we recommend acceptance of the grant. Also, that Cindy Becker be authorized to sign all necessary documents on behalf of the Board of Commissioners.

The Children, Youth, & Families Division (CYF) of Health, Housing and Human Services requests the approval to apply for a grant from the U. S. ### Approval of a Professional, Technical, and Consultant Service Contract with <u>LifeWorks NW for a Promatora Program</u>

The Clackamas County Community Health Division (CCCHD) of the Department of Health, Housing & Human Services (H3S) requests the approval of a Professional, Technical, and Consultant Service Contract with LifeWorks NW for a Promatora Program.

The Promotora Program is an innovative pilot project that will allow the County to provide increased services to County consumers. It consists of a bi-lingual prevention and education program designed to help Latino families access community resources, build basic parenting skills, increase positive family interactions and access mental health services through home visits and parenting classes.

This contract is retroactive back to March 15, 2010 due to some additional time being needed to obtain signatures.

The total amount is \$424,166 over a three-year period. It is financed by re-investing un-spent capitation funds. No County General Funds are involved. County Counsel has reviewed and approved this contract as part of the H3S contract standardization project. It terminates on February 28, 2013.

#### Recommendation

We recommend the approval of this contract and further recommend that Cindy Becker be authorized to sign on behalf of the Board of County Commissioners.

The Clackamas County Community Health Division (CCCHD) of the Department of Health, Housing & Human Services (H3S) requests approval to apply for the Justice and Mental Health Collaboration Program FY 2010 Competitive Grant with the U.S. Department of Justice through the Bureau of Justice Assistance (BJA).

Funding through this grant will allow CCCHD to plan for and collaborate with Clackamas County Community Corrections, the District Attorney and the Courts to increase services to specialty populations with co-occurring mental health and substance abuse disorders as well as other organic brain disorders. If awarded, Community Corrections will require approval to add an additional part time position (.50 FTE).

The total potential funding is up to \$250,000 for planning and implementation. This funding is spread over a twenty-four month period.

### Approval Amendment #3 to the Contract with LRS Architects Inc. for the Clackamas County Jail Renovation Design

On May 7, 2009, the Board of Commissioners approved a contract with LRS Architects Inc. to renovate the existing Clackamas County Jail to accommodate additional capacity and update critical systems. LRS Architects Inc. was selected for this project because of their ongoing participation in the development of the Adult Detention Facility project. LRS proposed to provide design services as well as oversight of the necessary subcontractors to provide complete structural, mechanical and security electronics engineering, as well as landscape design.

The initial project contemplated the placement of an Early Resolution Court function in the Jail facility. Near the end of the development of the design process it was determined that the Early Resolution Court function would not be placed in the facility and that the design should be revised to repurpose the area. This amendment reflects the work associated with the multiple design iterations and document revisions associated with the removal of the Early Resolution Court and the subsequent re-planning of Block B and revision to the South Station design.

This is the third Amendment to the original contract. Amendment #1 addressed the addition of a waterline replacement requested by the City of Oregon City and video visitation systems to the project. Amendment #2 provided for a limited asbestos and lead paint survey to be conducted.

This amendment has been reviewed and approved by County Counsel.

Funds for this contract will be included in the Sunnybrook/Jail Renovation project financing under budget line 420-0221-00-431000-76077 The total amount of this contract is not to exceed \$1,022,945.00 (original \$850,490.00 + Amendment #1 \$72,700.00 + Amendment #2 \$6,645.00 + Amendment #3 \$93,110.00).

### RECOMMENDATION:

Staff respectfully recommends that the Board approve Amendment #3 with LRS Architects, Inc. for the renovation of the Clackamas County Jail.

Termination of Lease between North Clackamas School District and Clackamas County for the Sunnyside <u>Village Community Center, located at 13793 SE Sieben Parkway, Clackamas, Oregon</u>

In 1997, the North Clackamas School District (NCSD) and the County signed a twenty-five year lease to use the Sunnyside Village Community Center for extra classrooms.

NCSD is no longer in need of leased space since the completion of its new schools.

Clackamas County is interested in remodeling the Sunnyside Village building for use as a Library. This Library building would allow the Clackamas Corner Library to give up its lease payments, move east of I-205 and provide much needed library services to the Happy Valley, Sunnyside and Clackamas residents.

Both parties agree that neither party is in default or in breach of the Lease Agreement by entering into the Termination Agreement. The parties agree that possession and control of the Sunnyside Village Community Center property shall revert back to the County effective as of the date of the signing of the Termination Agreement.

The County Library will reimburse NCSD \$151,000 from the library's construction fund for the tenant improvement made to the property by NCSD.

# Amendment to Facade Easement and Authorization of Funding For the Cascade Ski Club Lodge Façade Improvement Project in Government Camp

The Façade Improvement Program provides funding to property owners to improve their building facades. The program provides up to \$80,000 to properties within the commercial core area for qualified improvements. To date 14 properties have participated in the program, significantly improving the appearance of the community.

The Cascade Ski Club has a lodge located in the core area of Government Camp. In 2000, the club completed façade improvements that included new windows, paint, lighting and some stonework. In 2009, they requested additional funding to add more stonework to the façade. The request was approved by the TIF advisory committee. The work has been completed and, based on the program guidelines are due to be reimbursed \$23,826 at this time.

A façade easement is already in place that provides the Agency security that improvements made with urban renewal funds will remain intact. This easement must be amended to include the funding for this second phase of improvements.

### Recommendation

- Approve and accept the attached amendment to the façade easement.
- Record the easement in the Deed of Records of Clackamas County at no cost to the Clackamas County Development Agency.
- Authorize the Board Chair to execute all documents necessary to conclude this transaction.
- Authorize staff to issue a reimbursement of funds.
