REQUEST: Approval of a second letter requesting a 30 day extension to the public comment period for a total of 90 days.

BACKGROUND:

ODOT has released the Environmental Assessment (EA) for the I-205 Toll Project. The EA consists of over 2,000 pages of analysis and detailed information about the I-205 Toll Project proposal. Details regarding the EA can be found on the Oregon Department of Transportation (ODOT) website at https://www.oregon.gov/odot/tolling/Pages/I-205-Tolling.aspx.

ODOT announced last week that they will extend the public comment period by 15 days which results in a 60 day public comment period. While we appreciate the minor extension, staff continues to assert that a 90 day comment period is needed to review the thousands of pages of technical information, draft comments and coordinate through the board and committees. For that reason, staff is seeking Board approval for a second letter to ODOT and Federal Highway Administration (FHWA) requesting an additional 30 days to extend the public comment period to 90 days. Assuming no additional extension is granted, staff has developed an updated timeline noting significant dates. See Attachment B.

Dear Ms. Putney,

We are aware that the public comment period for the I-205 Toll Project Environmental Assessment (EA) was extended by 15 days to April 21st, 2023. While we appreciate the small extension we **do not feel that the 60 day public comment period is sufficient.** The Environmental Assessment includes thousands of pages of information that must be reviewed and analyzed before comments can be developed. The proposed additional 15 days of review time does not provide sufficient time for analysis, material development and coordination through this body.

We also remain concerned about the lack of opportunities for public engagement. Two webinars, one three-hour public hearing, and a survey all set to occur within 45 days will not provide sufficient opportunity for our community members to become informed and have the opportunity to provide feedback. Additionally, the proposal to set up Information Tables at local grocers and libraries during normal working hours will not reach the majority of residents. More time and more accessible opportunities are needed.

You are proposing a major change to how our transportation system (both on and off the highway) will function as evidenced by the extensive analysis presented in the EA. This proposal will cause significant impacts to our communities which we do not take lightly.

Therefore, as a participating agency for the I-205 Toll Project Environmental Assessment, <u>we</u> reiterate our request that you extend the public comment period to 90 days by adding an additional 30 days. This extension will allow adequate time for review and public engagement.
