

## Appointed Boards and Commissions (ABCs) Recommendation

The Enhanced Law Enforcement District Advisory Board, staffed by the Clackamas County Sheriff's Office currently has 3 openings on their commission due to term expirations and resignations. 11 members are allowed with 3 year terms.


Recruitment opened to the public on 1/5/23 and closed on 2/1/23. Recruitment took place by press release and the county website. Through this recruitment process, 3 applications were received and 3 were recommended to be appointed. 2 applicants are new and 1 applicant is currently on the board. Interviews were conducted with all eligible applicants.
