WHAT ACTION ARE YOU REQUESTING FROM THE BOARD?

The purpose of this study session is twofold:

• Provide the Board with an overview of the Early Learning Council proposed by the Governor, the status of the Council in the Legislature, and the impact on Clackamas County.

Seek approval from the Board to apply to become the lead agent for the Clackamas County Hub
to integrate and purchase contract for local supports to positively impact kindergarten readiness
for at-risk children.

EXECUTIVE SUMMARY:

Early Learning Council Background

The Early Learning Council - part of the Governor's overarching education initiative- is focused on integrating and streamlining existing state programs for at-risk youth and ensure all children are ready to learn when they enter kindergarten.

The Early Learning Council (ELC) was established in SB 909 in 2011, and was further defined in HB 4165 in 2012. As a result of this legislation and the legislatively approved budget in 2012, funding for local commissions on children and families will be eliminated June 30, 2013.

In place of county commissions on children and families, the current bill before the legislature calls for creating a pilot "community-based coordinators of early learning services," also called regional hubs. The idea is that different groups or agencies will step up in different parts of the state to coordinate local early childhood services. These hubs will focus on children, ages 0-6, who are at risk of not being ready for kindergarten due to poverty and adverse childhood experiences. Hubs must develop strategies to identify, reach and support these children.

The Early Learning Council service delivery system will involve the implementation and oversight of early learning services in communities throughout the state. Programming and services will be provided through a wide array of stakeholders including social service providers; schools; churches; businesses; tribes; civic groups; parents; regional and local human, health and juvenile justice service governmental entities; youth; and general community members.

Services include screening all Oregon babies at birth, 9 months, 18 months and age 3 to detect whether they are reaching milestones; making it easy for families to navigate programs; evaluating every kindergartner's readiness to find the gaps; and having every state-funded program, including health, nutrition and parenting programs, focus on and report school-readiness results.

The delivery system of Community-based Coordinators of Early Learning Services are designed to ensure that providers of early learning services are accountable, that services are provided in a cost-efficient manner, and that they are focused on outcomes.

(Note: Related to, but separate from, the ELC legislation is the creation of the Youth Development Council to oversee services to children and youth from 6-18 in a manner that supports academic success and reduces criminal involvement. Both the Juvenile Department and H3S are closely tracking this legislation.)

CYF's Transition from Commission on Children & Families model to the Hub model

For the last two years, CYF has led a process to transition from the Commission on Children Families model and to align Clackamas County as the preferred applicant to become the Community –based Coordinators of Early Learning Services Hub.

Work to-date

To-date, CYF has led the Clackamas regional effort to ensure that Clackamas County residents would benefit from the new Hub model as early as possible. To this end we have brought together school districts, social service providers, community members, early intervention, childcare and early learning professionals, health care practitioners, educators and others to align collective assets towards the common goal of kindergarten readiness.

Leadership from the stakeholder groups all agreed to be become part of what is being called the Advisory Committee for the Clackamas Early Learning Collaborative (ACCEL). The ACCEL charter document focuses the work to be accomplished leading to the submission of a Request for Application (RFA) to the State Early Learning Council. Our intent is to use the charter as guiding principles for future work of the group if awarded a Hub certification.

Although Hubs will look different throughout the state, each Hub will have the following five characteristics:

- Family Centricity
- Reaching the highest risk children
- · Coordinated and transparent budgeting
- Accountability
- Flexibility

The Hub administrative functions align with current CYF administrative functions. Operational functions include:

 Conduct system and service assessments focused on increased efficiency, reduced duplication of efforts and decreased burden on families. Determine existing resources and gaps, and coordinate cross-sector strategies;

- 2) Map and coordinate funding and resource allocation to maximize efficiency, effectiveness and return on investment:
- 3) Integrate and coordinate outcome-based service delivery and funding streams;
- 4) Contract and collaborate with providers, targeted at high-risk children and families; and
- 5) Report kindergarten readiness and developmental milestone outcomes at a child-level from prenatal through kindergarten for children in our service area.

FINANCIAL IMPLICATIONS (current year and ongoing):

As of the writing of this report, specific funding arrangements are still being debated at the legislature. The estimate for base funding for the Hub is \$200,000. There is also the opportunity for incentives based upon achieving local targets for system level outcomes. This is in addition to the service contracts themselves that would be administered by the Hub.

RECOMMENDATION:

Apply to be an early adopter/pilot:

Based on the work CYF's work as the local Commission on Children and Families, designation as the Early Learning Hub is a natural evolution. CYF has earned a reputation as a collaborator that brings folks together to get the work done. To that end, staff has convened numerous stakeholders at the policy and operations levels to develop a model that works for the county. Because of this groundwork over the past couple of years, Clackamas is viewed as a leader in getting this off the ground. Additionally, CYF works together within the department to collaborate on mutual projects and outcomes.

Helping at-risk families and children – through community partners - is what we do best. And we believe that being part of the solution early on will put us in a position to help shape the policies and related activities in the future.

ONGOING OPERATING EXPENSES/SAVINGS AND STAFFING (if applicable):
Cost of 1.5FTE would be charged to Hub contract between Clackamas County and Oregon Education Investment Board.
ANTICIPATED RESULTS:
At this point in time, we anticipate a minimum of \$200,000 to fund the Hub infrastructure. It is very difficult to determine the full funding package, but based on the current Clackamas contract for Commission on Children and Families early childhood services we anticipate upwards to \$1million for services funded through the Hub structure.
