Notice is hereby given that Clackamas County, by and through the Health, Housing and Human Services Department (H3S), Social Services Division, Aging and Disabled Services ("SSD-ADS") is conducting a Notice of Funding Opportunity (NOFO) Request for Qualification (RFQ) process for the delivery of Older Adult Community services (nutrtion, transportation and social services) for the City of Happy Valley.

OVERVIEW:

This preliminary Request for Qualification (RFQ) will determine which organizations are qualified to make an offer to provide Nutrition Services, Social Services and/or Transportation, for the City of Happy Valley services through a detailed Request for Proposal (RFP).

SSD-ADS receives supportive federal Older Americans Act Title III funds and state funds to help support the system and has the responsibility to plan, develop, and coordinate services for a comprehensive delivery system for citizens age 60 and older. Since Older Americans Act funding is supportive funding, the expectation is that applicants have the means to meet match requirements, 11.13% for nutrition programming, as well as cover the majority of program costs. Current awards cover less than 30% of the cost of total program delivery.

Older Americans Act funded program services are age based. Any persons over age 60 residing in the designated service area is qualified to receive services. Per the Civil Rights Act of 1964, no person qualified to receive services shall, on the basis of race, color, or national origin, be excluded from participation, be denied the benefits of, or be subjected to discrimination under any County program, service or activity.

This process may result in Subrecipient Grant awards to multiple providers during fiscal year 2020-21 (July 1, 2020 - June 30, 2021) that will be effective as early as September 1, 2020. With satisfactory performance, any Subrecipient Grant Agreement issued through this award process may be renewed annually for four additional years.

Awards amounts will be based on available funding, service area, and anticipated persons served. The initial award has not yet been determined and is dependant on services provided. The City of Happy Valley may be willing to provide some additional financial support for service delivery to the quailed applicant.

Reporting is submitted to SSD-ADS on a monthly basis and must include completed client activity logs as well as nutrition program reports. These report must accompany the monthly reimbursement requests.

If any of our existing providers that wish to to providing services to a new service area must submit a letter of intent to expand services as part of this RFQ process. Letters of Intent must be received within the RFQ deadline outlined in Section (9) of the Request for Qualifications below.

SERVICES:

Older Adult Nutrition Program:

- a) Congregate and Home Delivered meals for older adults age 60 and older. Meals
 offered under this program must meet the requirements outlined in the State of Oregon,
 Dept. of Human Services, State Unit on Aging's Oregon Congregate and HomeDelivered Nutrition Program Standards.
 - i. Food Service is the production of meals for the congregate and home delivered meal recipients. Each meal must contain at least one-third of the Recommended Dietary Allowance (RDA) as established by the Food and Nutrition Board, National Research Council - National Academy of Science. A unit is one meal prepared and served/ delivered.
 - ii. Meal Site Management includes such tasks as: supervising final on-site preparation and serving/delivery of meals to eligible congregate and homedelivered participants; recruiting, training, scheduling and monitoring program volunteers; determining eligibility of participants including home visits to home delivered meal participants; collecting and accounting for participant donations; completing and submitting required budget and program reports, providing events and activities for meal site participants; meeting with meal site Advisory Committee; and publicizing meal site in the community to enhance visibility and encourage participation. One unit is one meal served/delivered.
- b) The successful Home Delivered Meal provider will also become the Medicaid Home Delivered Meal provider for this designated service area.

The Older Adult Social Services:

- a) Case Management an in-depth interview with a client to provide access to an array of service options to assure appropriate levels of service and to maximize coordination in the service delivery system. Case management must include four general components: access, assessment, service implementation, and monitoring
- b) Reassurance Regular friendly telephone calls and/or visits to physically, geographically or socially isolated registered clients that are receiving services to determine if they are safe and well, if they require assistance, and to provide reassurance
- Information & Assistance Consists of request for assistance locating resources to meet a specific need, or assistance prioritizing and locating resources to meet multiple needs

Transportation Services:

a) To provide one-way rides for older persons. The goal is to ensure that transportation needs are met for those who are unable to meet their transportation needs independently. OAA funded rides are scheduled for persons who are age 60 and older for trips to medical appointments, clinics, personal business and to senior center activities.

REQUEST FOR QUALIFICATIONS:

- 1. Brief description and history of your organization, including relevant experience providing the service proposed for contracting.
 - a) Nutrition Services: Home Delivered Meal/Meals on Wheels (at a minimum) and Congregate dinning.

- 2. Description of Insurance and Bonding procedures. (Note: At the expense of the Applicant, Clackamas County requires a \$1,000,000 liability policy which includes the County as an additional insured and holds Clackamas County harmless.)
- 3. Evidence of your organization's legal power to contract, be incorporated and have legal authority to operate in Oregon and enter into contracts or other legal agreements. Your organization must also be currently registered in both DUNS and SAM as well as not be prohibited from receiving federal funds.
- 4. A statement of fiscal solvency. (Note: Your organization must be able to ensure working capital to cover program expenses for at least 60 days.)
- 5. Evidence of a certified audit, I-990 filing for Non-profits, or an independent financial review for small companies was performed within the last two years.
- 6. A statement that your organization adheres to Equal Opportunity Employer Affirmative Action standards and has adequate personnel policies in effect.
- 7. An up-to-date organizational chart of existing structure and chart showing where proposed service would fit into that structure.
- 8. Brief description of:
 - a) Ability to provide direct services to clients.
 - i. Case Management/Reassurace
 - ii. Information & Assistance
 - iii. Nutrition Services Home Delivered Meals and/or Congregate
 - iv. Transportation Services
 - b) Ability to transport food from meals preparation site to program participants while maintaining safe food temperatures.
 - c) Any plans to subcontract service where capacity for direct services is limited.
