Funds to build the Jenning Lodge park have not been allocated but funds to ask the community what they want is funded.

FIFTH TOPIC : Update on Gladstone Library

1. Letter sent to Board of CC about concerns. The County Administrator said that the unincorporated community gets to weigh in about how funding is spent but no process for the unincorporated community to provide feedback. Gladstone and Concord library build is in progress. Week of May 28th is the budget committee process for the entire county and the budget will be voted on. The library history space small group will be meeting May 6 at 3 PM at the current Oak Lodge library to continue developing guidelines for its use and catalog materials already on hand for the new history space in the Oak Lodge library currently under construction. Three of the members are from Jennings Lodge. They would welcome more if anybody would like to join.
